- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. - 6. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 7. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 8. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 10. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 11. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- 12. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified,

then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the

original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- I. SPECIFICATIONS:
- 1. The covers shall be of the best quality and shall conform to B.I.S. (Bureau of Indian standards) specificat ions. IS: 14611-2016 as amended up to date.

a) Size of cover: 10 x 10 (mtr)

b) Mass per unit: 200 GSM.

c) Colour: Blue/Black.

- d) Workmanship:-The cover shall be uniform in Colour, texture and finish and shall be free from blisters , c reases of permanent nature, cuts, pinholes and other visual defects.

Testing Parameters: Testing shall be done as per the latest BIS standards applicable.

PRE-DELIVERY INSPECTION AND TESTING The supplier shall give a 10-day advance notice to NSC for inspection readiness. Inspection will be conducted at the supplier's premises by a designated committee represe ntative fro m NSC. The supplier must provide all necessary resources for inspection at its own cost. TA /DA for NSC officials shall be borne by NSC, except when the supplier fails to offer the inspection after giving n otice, in which case, the cost will be recovered from the supplier. Inspect ion parameter shall check for the following:

- (a.) Dimensions.
- (b) Eye lets (if Any as per requirement)
- (c) Sealing of joints (if any)
- (d) Any other defects

Inspection of the covers will be carried out both at the premises of the supplier and at the receiving unit. W hile sampling for testing shall be done by committee at the supplier's end, the receiving u nit shall inspect to assure that the covers inspected and marked by the committee have been received in good condition. S uch covers which are approved at the time of inspection at the manufact uring unit and the destination will only be accepted.

SAMPLING 5 samples per 100 (Tirpal Covers) will be drawn of which, 4 samples are to be sent to the desig nated lab. 1 shall be retained as a guard sample. Concerned region/farm shall coordinate with the supplier accordingly regarding the status of test report and give instruction s for dispatch immediately after receiving test report. Testing charges will be borne by NSC.

Method of Sampling: Sample sheet measuring 2 sq. meters shall be cut into triplicate out of the cover sele cted for lab tests. The sample piece shall be drawn in such a manner so that portion having joint with heat sealed is also covered in the sample. The portion from where samples have been drawn for lab. Test shall be mended by the Suppliers by replacing additional sheet of identical material with triple heat sealed imm ediately after the sampling has been completed at the place from where samples were cut out. The sample shall be referred to any Govt. Laboratory/NABL/ILAC Accredited lab certified for conducting relevant detailed tests as per applicable latest IS standard)

The dispatch instructions of the material shall be given to the Supplier only after the material is cleared by the lab tests. \cdot

DELIVERY PERIOD The delivery period for completing the order shall be 21 days from the issuance of the P urchase order. The time required for testing of samples will be excluded from the delivery period for supply of fumigation covers (From the date on sample drawn to date of receipt of the clearance for dispatch by the supplier)

REMOVAL OF DEFECT: If upon inspection, any defects of whatsoever nature, are pointed out by the Corpor ation/Pu rchaser or his nominee, it shall be the duty of the supplier to rectify the same as far as they are wi thin specifications mentioned in the supply order and replace within 2 weeks from the date of communicati on of defects. The date of receipt after removal of defects will be const rued as date of receipt for the purp ose of calculating delivery period at his own cost.

MARKING: Each cover shall be marked by the Supplier at his expenses distinctly and clearly indicating the supply order No. with date, name and address of the consignee, name of supplier and s erial No. of the cover for the purpose of identification. All marking shall be carried out with such a material as may be found s atisfactory by Inspecting Officer(s)

GENERAL TERMS:

The rates should be quoted for the offered items on the basis of F.O.R destination door delivery, inclusive o f GST, Packing & Forwarding charges, loading & unloading charges etc. The inspection, verification and tes ting charges will be borne by NSC and hence should not be included in the rates offered.

In case of material supplied is of inferior quality/outside the given quality parameter/supplied outside the s tipulated delivery period, NSC reserves the right to accept/reject the material accordingly.

Past Performance Criteria: The past performance of in Central Govt./State. Govt./PSUs will be taken into consideration for the bidders participating in the bid.

NSC reserves the exclusive right to terminate the contract or bid as and when required without assigning a ny reason.

Arbitration Clauses:

In case any dispute arises between NSC and the other party due to any term or matter, both the parties wil I opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discus sions, then it shall be binding upon parties to resolve issues under the provisions of Arbitration & Conciliati on Act, 1996 as amended from time to time. Under this provision, the Chairman-cum-Managing Director, N ational Seeds Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall be in English Language. The court of Delhi shall have the jurisdiction.

As per the Guidelines of Arbitration & Mediation in Contracts of Domestic Public Procurement issued by Th e Department of Expenditure Procurement Policy Division under Ministry of Finance, Govt. of India through OM No. F.1/2/2024-PPD dated 03.06.2024, the arbitration shall be restricted to disputes with a value less t han Rs. 10 crore. This figure is with reference to the value of the dispute (not the value of the contract, whi ch may be much higher). In all other cases where value of dispute is above 10 crore, arbitration will not be a method of dispute resolution in the contract.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
