- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. 2. Delivery Period:

- a) Overall delivery period will be One (1) year from the date of issue of contract.
- b) The material is required to be supplied throughout the year on 'as and when required' basis.
- c) As per requirement of India Government Mint Kolkata, the successful bidder/firm will be intimated for del ivering the desired quantity in multiples of 100 pcs and Minimum quantity to be ordered is for 100 pcs (unl ess the remaining quantity becomes less than 100 pcs). It implies that the successful bidder has to submit necessary Material Security suitably so as to be eligible for lifting the Fine silver (999) raw material proport ionate to minimum 100 pcs of finished Silver plates.

4. Warranty

- a. The supplier warrants that the goods supplied under the contract shall have no defect arising from desi gn, materials (except when the design adopted and / or the material used are as per specifications of India Government Mint, Kolkata) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
- b. The warranty shall remain valid for **Twelve (12) months** after the goods or any portion thereof as the c ase may be, have been delivered to the final destination and accepted by India Government Mint, Kolkata in terms of the contract or for fifteen months from the date of despatch from the supplier's premises for do

mestic goods, whichever is earlier.

- c. In case of any claim arising out of this warranty, India Government Mint, Kolkata shall promptly notify the same in writing to the supplier. Upon receipt of such notice, the supplier shall, with all reasonable speed, repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination.
- d. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on India Government Mint, Kolkata for such replaced parts/ goods thereafter. The total amount of material custody security is ₹ 4,71,70,282.50/-, considering rate of fine silver as ₹ 100. 98 per g (as on 04/06/2025) for total quantity of fine silver (999) to be provided as 467125 g.

As per requirement of India Government Mint Kolkata, the successful bidder/firm will be intimated for delivering the desired quantity in multiples of 100 pcs and Minimum quantity to be ordered is for 100 pcs (unless the remaining quantity becomes less than 100 pcs). 7. Packing:

The oval shaped plates shall be packed in an exquisite velvet box covering with soft foam and premium quality blue velvet outside and a silicon frame inside which is to be covered with suitable blue cloth to have proper fixed grooves to accommodate wooden stand and silver plate. Top of the Box has to be printed with desired Logo (to be provided by India Government Mint Kolkata) in bold letters. Velvet Box has to be packed in a transparent pack or zip lock pouch along with a proper sticker of name of the person & employee ID whose plate has been packed inside. Silver Plate has also to be tightly packed separately with LD Polyth ene sheet before keeping it into the box to avoid any scratches. All the velvet boxes have to be supplied in wooden carets instead of carton boxes in not more than 25 pcs in a single crate to prevent any damage.

8. Insurance:

The supplier shall make arrangements for insuring the goods against loss or damage, incidental to manufa cture or acquisition, transportation, storage and delivery. The Supplier shall be responsible till the entire g oods contracted for arrive in good condition at destination. The transit risk in this respect shall be covered

by the supplier by getting the goods duly insured. The insurance cover shall be obtained by the supplier in its own name not in the name of India Government Mint, Kolkata or its consignee. For details please refer to clause 12 of General Conditions of Contract (GCC).

9. Quantum of LD:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, India Govt. Mint, Kolkata shall, without prejudice to other rights and remedi es available to India Govt. Mint, Kolkata under the contract, deduct from the contract price, as liquidated d amages, a sum equivalent to the 0.5% of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

10. Parallel Contracts

(i) Parallel contracts, with more than one bidder (for the same contract) may be concluded in the following cases:

After due processing, if it is discovered that the quantity to be ordered is far more than what L1 alone is ca pable of supplying and there was no prior decision/ declaration in the bidding documents to split the quant ities, then the quantity being finally ordered may be distributed among the other bidders by counter offering the L1 rate in a manner that is fair, transparent and equitable based on objective data available in the bids e.g. eligibility data, Quantity/ Delivery etc.

In case of splitting in two, the ratio will be of 60:40, may be used – a different ratio may also be justified. These ratios are approximate and India Government Mint, Kolkata reserves its right to marginally vary quantities to suit capacity of the firm/ unit loads of packing or transportation. However, the requirements may not be split into a number of tenders of smaller quantities for the reason that one supplier may not be able to supply the entire quantity. It is also to mention in such cases that the firms should not quote for less than 25% of the tendered quantity; otherwise, their offer would be considered as unresponsive.

Before splitting the quantity, it should be ensured that the L1 price is reasonable. If it is not reasonable, ne gotiation with the L1 party may be carried out, if justifiable, with the approval of the CA. The following guid elines are to be considered while opting for parallel contracts:

- i) L1 should be awarded at least the percentage mentioned above or his spare supply capacity, whichever is lower; and
- ii) For the rest of the contract quantity, the lowest rate accepted will be counter offered to the L2 party. On acceptance of the counter offer, the order will be placed on L2 for the respective percentage or the spare s upply capacity of the L2 bidder, whichever is lower, and so on, to other tenderers. In case of non-acceptance of the counter offer by the L2 party, a similar offer shall be made to L3 and L4, and so on.
- **11.** The total cost inclusive of all as cited above on FOR India Govt. Mint, Kolkata (W.B) basis should be ind icated clearly both in words and figures in the price bid.
- 12. Documentary evidence to be submitted towards PAN & GST Registration Certificate.
- **13.** Participating Bidder must submit sealed and signed copy of entire GeM bid document including the Bu yer Specification Document. Also the participating bidder must submit duly filled, sealed & signed **Annexu re I, Annexure II &** documents as per **Annexure III** in their letter head attached under Buyer Specificati on Document.

16. Price Schedule:

Price to be mentioned only in price bid not in Techno commercial bid or any other place. If it is mentioned any other part other than price bid, the offer will be rejected.

17. Qualification/ Eligibility Criteria

The bidder firm should meet following eligibility criteria to qualify: -

A. EXPERIENCE & PAST PERFORMANCE : The bidder should have experience of having successfully co mpleted similar kind of services for the value at least Rs.18.28 Lakhs in any one of the last five years ending on 31.03.2025.

- **B. CAPABILITY -** The bidder must have capability to provide the relevant services.

- (ii) Supporting documents to be furnished as claim against the above Financial Standing: all financial standing data should be certified by certified accountants, e.g. Chartered Accountants (CA) in India.
- (iii) Non-submission or incomplete submission of documents may lead to rejection of offer.
- (iv) For MSEs and Start-ups (registered for the tendered item) all financial criteria shall be exempted.

18. MSME & Make in India Status:

In case any bidder is submitting their bid as MSME and/or MII, the firm must be registered as a MSME & MII in GeM portal and Self-declaration along with documentary evidence in this regard must be submitted declaring that their MSME & MII status is updated in GeM portal also. In further evaluation stage if it is found that the firm is not registered as MSME and/or MII in GeM, but MSME certificate and/or MII declaration is submitted along with the bid, no exemption will be given and their offer may be rejected.

19. Price Preference for MSE:

MSE quoting price within price band L1 \pm 15% may be awarded 25% of the total tendered value provided t hey agree to match the L1 price. 24. Resolution of Disputes:

If dispute or difference of any kind shall arise between India Government Mint, Kolkata and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, depending on the position of the case, either the purchaser or the supplier shall give notice to the other party of its intention to commence arbitration. 25. Risk Purchase Clause:

- (i) Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores from ot her agencies at the risk and consequence of the supplier. The cost difference between the alternative arra ngement and supplier tendered value will be recovered from the supplier.
