- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. - 2. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Firms not registered with DGAQA or any other Govt agencies must s ubmit requisite document for capacity assessment to the purchaser (failing which these firms may be disq ualified at TEC stage). If required & considered necessary, a composite delegation may be deputed to asse s the Facility/ Capacity of vendor.
- 9. **Advance Sample.** After award of contract the seller shall submit quantity one of the item as a dvance sample to Buyer within 45 days from the date of contract if required by the buyer. Buyer will issue clearance for advance sample. In case of failure of any sample, the entire lot will be rejected. No claim by the seller whatsoever shall be entertained thereafter.
- 10. <u>Technical Evaluation Committee</u>: The bidder is required to upload all relevant certificates such as BIS licenses, type test certificate, approval certificates a nd other certificates as prescribed in the product specification given in the bid docum ent. If required & considered necessary, the Tech Evaluation Committee may call for a sample to be tested by a Govt. Lab/ NABL accredited labs and the results of the lab will be the sole criteria for the acceptance of the items.
- 11. <u>Liquidated Damages.</u> In the event of the Seller's failure to submit the Bonds, Guarantees and Documents, supply the stores/ goods and conduct trials, installation of equipment, training etc as spec ified in this contract, the Buyer may, at his discretion, withhold any payment until the completion of the contract. The BUYER may also deduct from the SELLER as agreed, liquidated damages to the sum of 0.5% of the contract price of the delayed/undelivered stores/ services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores.
- 12. **Termination of Contract**. The Buyer shall have the right to terminate this Contract in part or in full in any of the following cases:-

- (a) The delivery of the material is delayed for causes not attributable to Force Majeure after the scheduled date of delivery.
- (b) The Seller is declared bankrupt or becomes insolvent.
- (c) The Buyer has noticed that the Seller has utilised the services of any Indian/ Foreign agent in getting this contract and paid any commission to such individual/ company etc.
- (d) As per decision of the Arbitration Tribunal.
- (e) **Contract can be cancelled (fully/ partly)** unilaterally by the buyer in case items are not received within the contracted delivery period. Extension of contracted delivery period will be at t he sole discretion of the buyer, with applicability of LD clause.
- (f) In case of any forged documents/ any form of corruption/ prejudiced dealing during the validity of contract, the contract will be terminated immediately. Action against the bidder/ seller in consonance with DPM 2009 & GFR 2017 will be followed.
- 13. **Tolerance Clause.** To take care of any change in the requirement during the period starting fro m issue of bid documents till award of the contract, Buyer reserves the right to 25% plus/minus increase or decrease the quantity of the required goods up to that limit without any change in the terms & conditions and prices quoted by the Seller. While awarding the contract, the quantity ordered can be increased or decreased by the Buyer within this tolerance limit.
- 14. <u>Inspection Authority.</u> The inspection will be carried out by constituted Bd of Officers by th e Buyer.
- 15. **Warranty.** Except as otherwise provided in the invitation tender, the seller hereby declares th at the goods, stores articles sold/supplied to the Buyer under this contract shall be of the best quality and workmanship and new in all respects and shall be strictly in accordance with the specification and particul ars contained/mentioned in contract. The Seller hereby guarantees that the said goods/ stores/ articles w ould continue to conform to the description and quality aforesaid for a period of 12 months from the date of delivery of the said goods/stores/ articles to the Buyer or 15 months from the date of shipment/dispatch f rom the Seller's or standard warranty period as given by the OEM whichever is of a longer period.
- 16. **Correctness of the Quality and Quantity.** On receipt of stores at consignee's premises at CAS D Delhi Cantt, the stores are checked for ascertaining the correctness of quality, quantity and document. In case the stores are found deficient in any way, the consignee has the right to reject the stores even if the ese were inspected and cleared by the inspector.
- 17. The supplier shall be responsible for the safe delivery of the stores at the consignee's end and tran sit damage if any shall be promptly attend by him.
- 18. **Transportation.** Store in good condition will be delivered free at consignee premises at CAS D Delhi Cantt-10.

19. Performance security/ PBG.

(a) <u>For Indigenous cases.</u> After award of contract, the bidder will be required to furnis h a Performance Guarantee by way of Bank Guarantee through a public sector bank or a private se ctor bank authorized to conduct government business (SBI, ICICI Bank Ltd., Axis Bank Ltd or HDFC Bank Ltd.) for a sum equal to **3% of the contract value within 30 days** of receipt of the confirm ed order. If the PBG is not received within 30 days from the date of placement of Supply Order, the contract can be cancelled unilaterally by the buyer. Performance Bank Guarantee should be valid up to 60 days beyond the date of warranty. The specimen of PBG is given in Form DPM-15 (Available in MoD website and can be provided on request). In the event of failure/breach of c ontract PBG will be forfeited in order to compensate the loss to the buyer.

(b) <u>Foreign cases</u>: Not Applicable

20. **Option Clause.** Under this clause, the Purchaser retains the right to place orders for addition al quantity up to a maximum of **50%** of the originally contracted quantity at the same rate and terms of th e contract. This option is available during the original period of contract provided this clause had been inco rporated in the original contract with the supplier. Option quantity during extended DP is to be limited to 5 0% of balance quantity after original Delivery Period. This clause may be exercised in case of procurement from single vendor/OEM also subject to there being no downward trend in prices.

21. Force Majeure clause.

- (a) Neither party shall bear responsibility for the complete or partial non-performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.
- (b) In such circumstances the time stipulated for the performance of an obligation under the p resent contract is extended correspondingly for the period of time of action of these circumstances and their consequences.
- (c) The party for which it becomes impossible to meet obligations under this contract due to F orce Majeure conditions, is to notify in written from the other party of the beginning and cessation of the above circumstances immediately, but in any case not later than 10 (Ten) days from the mo ment of their beginning.
- (d) Certificate of a Chamber of Commerce (Commerce and Industry) or other competent authority or organization of the respective country shall be a sufficient proof of commencement and cess ation of the above circumstances.
- (e) If the impossibility of complete or partial performance of an obligation lasts for more than 6 (six) months, either party hereto reserves the right to terminate the contract totally or partially up on giving prior written notice of 30 (thirty) days to the other party of the intention to terminate wit hout any liability other than reimbursement on the terms provided in the agreement for the goods received.

22. Responsibility of the Contractor for Executing Contract.

- (a) **Risk in the Store.** The contractor shall perform the contract in all respect in accordan ce with the terms and conditions thereof. The store and every constituent part thereof, whether in the possession or control of the Contractor, his agents or servants or a carrier or in the joint posses sion of the Contractor his agent or servants shall remain in every respect at the risk of the Contractor until their actual delivery to the consignee at the stipulated place or destination or where so provided in the contract until delivery to the person specified in the schedule as interim consignee for the purpose of dispatch to the consignee. The Contractor shall be responsible for the loss, destruction, damages or deterioration of or to the stores from any clause whatever while the store after a pproval by the inspector are awaiting dispatch or delivery or are in the course of transit from the C ontractor to the consignee. The Contractor shall alone be entitled and responsible to make claims against Railway administration or other carrier in respect of non delivery short delivery, miss-delivery, loss destruction damage or deterioration of the goods entrusted to such carrier by the contractor for transmission to the consignee or interim consignee as the case may be.
- (b) <u>Consignee Right of Rejection</u> Notwithstanding any approval which the Inspector may have given in respect or any part of portion thereof or any materials or other particulars or the works of workmanship involved in the performance of the contract (whether with or without any test carried out by the contractor or the Inspector or under the directions of the Inspector) and not withstanding delivery of the stores where so provided to the interim consignee, it shall be lawful for the consignee, on behalf of the purchaser to reject the stores or any part portion or consignment thereof within 45 days after actual delivery thereof to him reckoned from the date of receipt of complete equipment with spare and accessories as ordered if such stores or parts, portion or consignment thereof is not in all respect in conformity with the terms and conditions of the contract wheth er on account of any loss, deterioration or damage before dispatch or delivery or during transit or otherwise however.
- (c) Provided that where, under the terms of the contract the store are required to be delivered to an interim consignee for the purpose of dispatch to the consignee the store shall be at the purc hasers risk after their delivery to the consignee, but nevertheless it shall be lawful for the consigne e on behalf of the purchaser to reject the store or any part, portion or consignment thereof upon th eir actual delivery to him at the destination if any are not an all respect in conformity with the

term and conditions of the contract except where they have been damaged or have deteriorated in the transit or otherwise after their delivery to the interim consignee.

- 23. **Fall clause.** The following fall clause will form part of the contract placed on successful Bidder:-
 - (a) The price charged for the stores supplied under the contract by the Seller shall in no event exceed the lowest prices at which the Seller sells the stores or offer to sell stores of identical description to any persons/ Organisation including the purchaser or any department of the Central government or any Department of state government or any statutory undertaking the central or state government as the case may be during the period of the Supply Order.
 - (b) If at any time, during the said period the Seller reduces the sale price, sells or offer to sell s uch stores to any person/ organization including the Buyer or any Department, of central Govt. or any Department of the State Government or any Statutory undertaking of the Central or state Gov ernment as the case may be at a price lower than the price chargeable under the contract, the sell er shall forthwith notify such reduction or sale or offer of sale to the Director General of Supplies & Disposals and the price payable under the contract for the stores of such reduction of sale or offer of the sale shall stand correspondingly reduced. The above stipulation will, however, not apply to:

(i) Ex	kports by	/ the	Seller.

- (ii) Sale of goods as original equipment at price lower than the prices charged for nor mal replacement.
- (iii) Sale of goods such as drugs which have expiry dates.
- (iv) Sale of goods at lower price on or after the date of completion of sale/ placement of the order of goods by the authority concerned under the existing or previous Rate Contracts as also under any previous contracts entered into with the Central or State Government Departments, including their undertakings excluding joint sector companies and/or private parties and bodies.

24. Risk & Expense clause

- (a) Should the stores or any installment thereof not be delivered within the time or times speci fied in the contract documents, or if defective delivery is made in respect of the stores or any insta llment thereof, the Buyer shall after granting the Seller 45 days to cure the breach, be at liberty, wi thout prejudice to the right to recover liquidated damages as a remedy for breach of contract, to d eclare the contract as cancelled either wholly or to the extent of such default.
- (b) Should the stores or any installment thereof not perform in accordance with the specifications/ parameters provided by the SELLER during the check proof tests to be done by the BUYER in the prescribed manner, the BUYER shall be at liberty, without prejudice to any other remedies for breach of contract, to cancel the contract wholly or to the extent of such default.
- (c) In case of a material breach that was not remedied within 45 days, the BUYER shall, having given the right of first refusal to the SELLER be at liberty to purchase, manufacture, or procure fro m any other source as he thinks fit, other stores of the same or similar description to make good:-
 - (i) Such default.
 - (ii) In the event of the contract being wholly determined the balance of the stores rem aining to be delivered there under.
- (d) Any excess of the purchase price, cost of manufacturer, or value of any stores procured fro many other supplier as the case may be, over the contract price appropriate to such default or ba lance shall be recoverable from the SELLER. Such recoveries shall not exceed 100% of the value of the contract.
- 25. **Payment Terms.** It will be mandatory for the Bidders to indicate their bank account numbers and other relevant E-payment details. A copy of the model mandate form prescribed by RBI to be submitted.
