- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. - 7. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having

In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original

delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

### 3. Generic

After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing– the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

### 1. Supply Timeline:

The qualified bidder shall supply the material within **30 days** from the date of issuance of the **Work Order**.

## 2. Bid Completeness:

Conditional or incomplete bids shall be **rejected** during technical evaluation.

### 3. Mandatory Documents:

The bidder shall submit **valid copies of PAN and GST registration certificates** as part of the t echnical bid.

### 4. Quoted Price Format:

The rates shall be quoted on a **F.O.R.** (**Free on Road**) basis, and must include all charges such as **loading, unloading, and stocking**.

#### 5. Turnover Proof:

The bidder shall submit a **copy of turnover documents for the last three financial years** as proof, enclosed with the technical bid.

### 6. Affidavit of Non-Blacklisting:

A notarized **affidavit on ₹10 stamp paper** must be submitted, stating that the bidder/firm/its pr oprietor has **not been blacklisted** and that **no FIR or court case is pending** against them.

### 7. Certificate Validity:

The issue date of all certificates submitted must be **prior to the bid start date**.

### 8. Experience Requirement:

The bidder must have **executed at least one similar supply work order** from any Government Department in the last **one years**. Relevant proof must be enclosed.

### 9. Right to Cancel:

The Department reserves the right to **reject any bid or cancel the tender at any stage**, without assigning any reason.

#### 10. **OEM Authorization:**

The bidder must submit a valid **OEM (Original Equipment Manufacturer) Authorization Certificate** as part of the technical bid.

#### 11. Inclusive Rates:

The rates quoted shall be **inclusive of all applicable taxes**, including **SGST**, **CGST**, **Income Tax**, **Labour Cess**, or any other statutory taxes.

### 12. MSME Exemption:

Bidders registered under **MSME** are **exempted from paying the EMD**. A copy of the **valid MSM E certificate** must be attached to the technical bid.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
