1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority : Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within $L-1+ 15\%$ of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 25 % of total quantity as defined/ decided in relevant policy.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- All terms must conform to the prescribed specifications and quality as outlined in the procurement order.
- The supplier shall ensure the delivery of approved item within the stipulated timeframe, as agreed upon during the procurement process.
- Supply shall be subject to inspection and quality verification by the Technical/Evaluation Committee.
- Release of Payment shall be subject to Inspection and Quality Verification by the Technical Committee and Purchasing Committee.
- The payment shall be made only after the receipt of the items in satisfying condition, as per the agreed specifications and upon submission of valid invoices.
- The quantity of the items can be changed subject to the availability of allotted budget.
- Timely completion and equitable distribution in a student centric manner.

8. Participants shall provide requisite documents/certificates
9. Supplier should provide sample alongwith the requisite documents for Technical Evaluation.
10. Any delay in delivery or non-compliance with the terms of the contract shall attract penalty mechanism as per the procurement guidelines.
11. The Bidder should be Original Equipment Manufacturer of the required items (OEM) or Authorized Dealer of OEM. Valid Factory license DIG and production capacity in terms of quoted model.
12. Safety and Quality standards: The manufacturer must possess certificate of ISO-9001-2015 (systems and procedures) and ISO -14001-2015(Environment), factory license and BIS Certification conferring IS 5405 (Latest Revision)
13. Test Report: The bidder should submit test report of quoted items/ model against each of bid being tested NABL.
14. Sample Evaluation: Sample evaluation will be stage-2 of technical bid and financial bid of only those bidders will be opened whose sample is declared qualified.
15. Upload an undertaking with the bid confirming compliance by the bidder is taking onus of this compliance. In case OEM is taking onus of this compliance, OEM undertaking is to be uploaded along with bidder undertaking.
16. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
17. The Original Equipment Manufacturer of the required items (OEM) or Authorized Dealer of OEM must have a valid OEM authorization certificate in favour of bid.
18. EMD must be in shape of Bank Guarantee, and no other document will be entertained. EMD to the tune of Rs pledged in the name of Chief Education Officer Bandipora and submit same by or before Tender closing Date & Time.
19. The bidder must submit Affidavit stating that the firm is not blacklisted by an Government or Semi Government authority.
20. The bidder (OEM) must submit the latest ITR certificate/Balance Sheet. If Authorized Dealer, please submit the said documents for both OEM and Authorized Dealer.
21. The bidder must submit bid specific MAF specifying details like Contact No. and Email ID of OEM.
22. The undersigned reserves the right to cancel the bid at any time.
23. There will be no compromise on the quality and specification of the items mentioned above.
24. The procured items shall be subject to the inspection and verification by the designated committee before final acceptance.
25. The quantity of items can be changed subject to the availability of allotted budget.
26. Any delay in delivery or non-acceptance with the terms of the contract shall attract penalty as per procurement guidelines.
27. The bidder should submit an Affidavit stating that the firm is not blacklisted by an Government or Semi Government authority
28. The bidder (OEM) must submit the latest ITR certificate/Balance Sheet. If reseller, please submit the said documents for both OEM and Reseller.
29. The bidder must submit following certificates:
 - GST Registration Certificate/latest GST clearance certificate.
 - BIS and Other Valid License as per IS 5405 (Latest Revision)
 - ISO 9001:2015 certificates

30. Past performance. The procured items shall be subject to the inspection and verification by the designated committee before final acceptance.

31. Any delay in delivery or non-acceptance with the terms of the contract shall attract penalty as per procurement guidelines.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
