- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
- 3. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 4. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in

the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

- 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost: or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

# 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

#### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

#### **Buyer Added Text-Based ATC Clauses:**

- 1. Alongside GeM's standard terms and conditions, the service provider is obligated to offer:
- a. A centralized messaging system for communication.
- b. Bi-weekly cleaning of seat covers.
- c. In addition to standard conditions on breakdown of vehicle in the GeM, in the eventuality of breakdown of vehicle the bidder would make alternate arrangement of vehicle immediately whether of his own or by using raid hailing application.
- d. An SoS alarm button (as mandated by MoRTH).
- 2. The bidder must have a registered office located in Mumbai district, Mumbai Suburban district or Thane district.

In case of MSE bidders, the Udyam registration certificate must have official address of enterprise in Mumb ai district, Mumbai Suburban district or Thane district.

In case of Start-up and Non-MSE bidders, the office/company registration certificate must have official addr ess in Mumbai district, Mumbai Suburban district or Thane district

The bidder must provide documentary proof of the registered office address.

- 3. Reporting place of monthly hiring vehicle will be fixed at the start of the month and won't be changed on daily basis. However, the reporting place may be changed in between the month only if is required on long term basis for days together.
- 4. The buyer can hire minimum of 0 (Zero) and a maximum of 4 (Four) SUV type vehicles with 1500 Km X 260 Hrs variant. The charges for extra kms & hours will be as per terms & conditions of GeM.
- 5. The Buyer does not assure a consistent hiring of vehicles. The demand may vary on a monthly basis and any changes will be communicated to the successful bidder before the start of each month.
- 6.The vehicle provided under "MONTHLY BASIS CAB & TAXI HIRING SERVICES" should only be designated f or use of the buyer during the contract period and the vehicle provided should not be used for providing se rvice to any party other than the Buyer, during off duty hours.
- 7. The vehicles under "MONTHLY BASIS CAB & TAXI HIRING SERVICES" are to be made available on all week as ys and on weekends & holidays as per the need of the office and without any limitation of time of day/night.
- 8. The service provider shall provide at his own cost proper uniform and badges and photo identity cards t o the drivers in compliance with the Motor Transport Workers Act.
- 9. The time and meter reading for the service shall commence and conclude at the designated reporting pl ace of duty. In addition to the actual vehicle run during the day, garage kilometres up to 10 Km per day sh all be admissible. The drivers of the vehicles should maintain log book on daily basis, each page of the Log Book should be indicated with the Registration Number of the Commercial vehicle. The log book should be got signed daily by the officer using the vehicle.
- 10. The vehicle deployed shall be parked at the Buyer's/ User's premises after the duty hours if desired so by the Buyer/ User and cannot be taken-out without written permission from the Buyer/ User.
- 11. The Speedometer of the vehicle shall not be tampered and in case of dispute/ suspicion i.r.o. tamperin g of meter, the view of the user of the vehicle will prevail.
- 12. The vehicles to be deployed should preferably be White/Off White in colour and should be either Petrol /CNG/Diesel driven. Further in case desired vehicles not available with bidder, the vehicle of higher segme nt are also acceptable without additional cost.
- 13. In case of CNG vehicle, CNG kit should be certified/company fitted and endorsed in RC.

- 14. The contractor should depute dedicated relationship Manager.
- 15. DoT Mumbai LSA reserves its right to accept or reject any or all Bids, abandon/ cancel the Tender proc ess, and issue another tender for the same or similar services at any time before the award of the contract. It would have no liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for such action(s).
- 16. In the area of operation of the vehicle, the definition of Local is area of Mumbai district, Mumbai Suburb an district and Thane district. Occasionally the vehicle may have to go for outstation duty for 24 days in a year. Further in case of overnight stay of vehicle, the charges as per GeM terms & conditions will be allowe d.
- 17. The Service Provider should provide bio- data of all the drivers duly verified by police, deployed on dut y to the DoT Mumbai LSA within 25 days in case of failure, a penalty of Rs. 3000/- per month (per driver) w ould be imposed on the Service Provider for up to two months and thereafter such unverified drivers shall be removed by the Service Provider simultaneously providing new driver, to be duly verified by police as mentioned above.
- 18. For Minimum average annual turnover of the bidder (for 3 years), the years considered will be 2022-23 . 2023-24 and 2024-25.
- 19. In case of Year of vehicle model under Technical specifications, the year of manufacture of vehicles will be considered.
- 20. If no bidder is qualified in initial technical evaluation, the TEC reserves the right to call for required doc uments from all bidders to make tender successful.
- 21. Each month, the vehicle can run up to 1500 Km. If it runs less than 1500 Km in a month, the remaining Km can be used in the next two months.
- 22. The driver must be well-mannered, well acquainted with Mumbai area and should attend the duty on time n proper and clean uniform and with valid during license. DoT, Mumbai LSA has the right to ask the agency for removal of the driver of a vehicle who is not found competent, orderly or disciplined. Any unsatisfactory performance or rude manner or such similar case from the Driver will attract penalty as per GeM terms & conditions
- 23. No mileage will be allowed for the drivers to take lunch / breakfast / dinner / filling fuel.
- 24. While claiming parking charges / toll charges etc. in addition to the monthly expenses, the receipts produ ed should bear the date of issue / vehicle Number and the Amount paid. Parking charges / toll charges etc shuld be entered in the log book also against the concerned date.
- 25. In case of unsatisfactory service, kilometrages or in any other respect whatsoever, the decision of the Dol Mumbai LSA will be final.
- 26. In case the bidder/seller desired to terminate the contract, it should give One month notice in advance to DoT, Mumbai LSA.
- 27. The rates accepted by DoT, Mumbai LSA shall remain unchanged till the currency of the contract.
- 28. The contract is liable to be terminated after giving 7 days notice, in case the services of the contractor are found unsatisfactory and /or any of the terms and conditions of the contract are violated.

29. All applicable laws, ordinances, statutes, rules, regulation, order or decrees in effect, issued by Government of India, State Government, local Municipal and other legal governing bodies, at the time of the contract sha apply to bidder/seller and its employees and representatives.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The

Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the सामान्य नियम और शर्तै/General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to this Service as provided in the Marketplace. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
