- 1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.

 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

 5. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE
- preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- 7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1.Experience Criteria:

The firm must have experience Supply/Overhauling of ETP/AMC of ETP/Operation of E TP 30% of the estimated cost within last ten(10) years from the date of Bid Opening in Ordnance Fys/Other Govt. Organization/PSU/Govt. undertaking/Private sector com pany. As credential work completion certificate along with work order both to be furni shed. If required capacity verification based on the data furnished by the firm in the t echnical bid may be undertaken if considered necessary by the competent authority at MSF.

It is mandatory for all bidders to submit the past experience certificate, there will be no exemption/relaxation MSE and start ups

- 2. Payment Terms: 100% Payment shall be done within thirty(30) days from the date of issue of Job completion Certificate issued by HOS/JWM/NGF section.
- **3.**Buyer Added Terms and Condition i.e. ATC will supersede the clauses of GEM GTC
- **4.EMD 2%(Rs.38,940.00)** of the estimated cost however exemption is applicable in submission of Micro & Small Enterprises having Udyam Registration Certificate Number issued by department of Micro, Small & Medium Enterprises (MSME) or firms regd. with Ordnance Factories/the Central Purchase Organization /the concerned minist ry / Department / startup as recognized by Dept. of Industrial Policy & Promotion (DIP P) or Central PSUs
- **5.** After placement of Supply Order firm will submit Security Deposit 5% of the Suppl y Order value in the form of Bank Guarantee/Term Deposit. Which will be valid upto two months beyond the work contract period.
- **6.**For delay in completion of the work beyond stipulated period L.D. shall be charged @ .5% S.O. value per week and part thereof subject to maximum 10% of the S.O. value.
- 7. Work Completion period: The work completion period will be Ninety (90) days from the date of placement of Supply Order
- 8. Working hours: Working hours: Working hours will be 08:00 hrs to 16:30 hrs on all working days except Sunday/Holidays. However, the working hours may be extended upto 20:00 hrs. with necessary permission. If required the firm may be allowed of work even on Sunday and Holidays also after obtaining necessary permission.
- 9. Guarranty/warranty: Firm will provide warranty one (01)year from the date of completion of the work. if any rectification/repair is require during this period, firm is bound to do this with out any financial demand.

- 10. The firm has to provide all tools and tackles for the execution of work.
- 11. The purchaser will not take any responsibility whatsoever, in the event of any accident met by contractor's men while on their duty. The contractor should submit the proper workmen compensation policy (insurance) at the time of requesting for entry permission.
- 12. The personnel deputed shall be below 60 years old, good health and physically it to work in hot, dust noisy, and smoky environment.
- 13. Firm will submit workman insurance certificate for all the workers engaged in the job.

14. **OPTIONAL SITE VISIT:**

The Bidder is advised to visit and examine to obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder.

The Bidder representative shall be allowed entry upon consignee premises for such visits. Only upon the express conditions that the Bidder will release and indemnity the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expense s incurred as a result of such visit.

The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding. Working condition weather etc. On its own before.

15. Safety:

Firm's offer will be inclusive of all safety equipment.MSF will not provide any safety equipment.

16. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates/documents sought in the Bid document. ATC and Corrigendum if any.

17. Buyer Added Bid Specific ATC

Bidder shall carefully read the clauses mentioned in ATC & shall attach the complian ce of the same duly signed and stamped. Mandate form to be submitted in prescribe d format.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
