- 1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. - 1. Weighment tolerance at +/-0.5% of each lot/consignment and quantity variati on +/-5% of ordered quantity.
- 2. Supply, transportation by rail/road up to **NTPC Lara** store/site, unloading and s tacking is in the scope of supplier. Safety norms applicable at the plant to be foll owed strictly while stacking and unloading.
- 3. Damage/torn bag or frozen/set cement will not be accepted.
- 4. Cement shall be supplied in HDPE bags of capacity 50 kg each, conforming to I **\$ 11652**: **1986**, bearing manufacture's name, week of manufacturing, and grade of cement.
- 5. Date of receipt of cement at site shall not be more than 2 weeks old from the d ate of manufacture.
- 6. Documents to be submitted:
 - a. Manufacturers Test Certificate against each week of manufacture as mentioned in the bag of c ement.
 - b. Delivery Challan/Invoice mentioning week of manufacture of cement.
- 7. The Manufacturers Test Certificate should indicate fineness, normal consistency, initial & final setting time, soundness, compressive strength, and any other test result as per tender specification.
- 8. Sampling & Testing:

- A) After receiving of cement at **NTPC Lara** Store/site, cement shall be te sted at **NTPC Lara Lab** for Fineness, setting time & Compressive stre ngth as per **IS 1489 PART-I.**
- B) In case of cement fails to achieve the desired minimum 28 days comp ressive strength as per IS 1489 PART-I at NTPC Lara Lab, sampling of cement shall be made in presence of representatives from C&M/stor e department, FQA department and supplier for the supplied quantity of each week number. Afterwards, the sampled cement specimen shall be tested at NTPC Approved Third Party Lab for Fineness, setting ti me & Compressive strength as per IS 1489 PART-I. The cost of the ab ove testing including transportation charges shall be borne by the supplier.

In case Cement fails to achieve the desired minimum 28 days compres sive strength as per **IS 1489 PART-I,** Supplier has to r eplace the total lot without any extra financial implication to NTPC. Lot means the total supplied quantity in particular week as printed on the bag of cement.

- 9. Payment Terms: The Consignee Receipt & Acceptance Certificate (CRAC) on G eM portal shall be generated for supplied cement only after meeting the quality requirement/acceptance criteria of that batch/lot of cement. The payment shall be done as per payment terms of GEM GTC i.e.,100% payment will be released within ten (10) days of issue of consignee receipt cum-acceptance certificate (C RAC) and on-line submission of bills.
- 10. Delivery Period: Supply to be done in 12 month in a staggered manner as per r equirement of **NTPC Lara only**. Cement to be supplied within 10 days of intima tion.
- 11. Vehicle deployed for transportation of cement shall have valid documents like valid national permits, Driver license, valid fitness certificate, PUC certificate etc as per rules.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
