If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. - 11 Warrantee / Guarantee** 1500 hours of operation / Six months of repair (whichever is earlier). Any defects which may appear within the liability period and arising in the opinion of the Engineer in-charge (Exc v) from lack of conformance with the drawings and specifications, required by the Engineer in-charge (Exc v) in writing shall be rectified by the contractor at his own cost within the time stipulated by the Engineer in-charge (Exc v). If the contractor fails to comply, the Engineer in-charge (Exc v) may employ other agencies to rectify the defects and recover the cost thereof from the contractor.
- 12 Work Completion Certificate** After completion of the warrantee / guarantee period, the bidder must apply in writing for the certificate (issued by the Engineer I/C (Exc v), Gokul OCM) to this effect.
- 13 Bidders should note the company rules regarding Abnormally Low Rates (ALR) (20% lesser than the departmentally estimated cost). In event of the bid falling in this category, Performance Security Deposit (@ 3% of the Award Value) in the name of "WCL Umrer Area" to be submitted prior to placement of Work Order.**
- 14** Under no circumstances, WCL is liable to provide any additional support including manpower, welding machine, welding electrodes, power / hand tools etc. and the any delays caused due to non-provision of the same shall be chargeable in bidder's share only.
- 15** Bidders are advised and encouraged to inspect and examine, at their own cost and risk; the Scope of Work and the Site of Work and / or obtain complete information about any relevant aspect about the job and make themselves acquainted with relevant details before participation. **No issues regarding the extent of job / scope of work shall be entertained during the execution of the job.** Any delay arising thereof shall be completely chargeable on bidder's account. **Participation by the bidder is sufficient to imply that the bid has been placed after inspection of site and the scope of work.**
- 16** Bidders may note the **purchase preference to the MSE bidders** as per prevalent procurement policy. Bidders' eligibility for consideration for purchase preference is subject to the certificate uploaded by the seller on GeM. In event of any dispute, the certificate uploaded and fetched from GeM shall be deemed as final and binding on all parties. **Seller should ensure that latest MSE certification is uploaded on GeM before participation in the bid for claiming the eligibility for consideration for purchase preference.**
- 17 Safety of manpower engaged by contractor:** Contractor will be solely responsible for the safety of the manpower engaged by him / her. The provision and use of PPE like safety helmet, safety shoes, safety jackets, gloves and other safety related items must be ensured by the contractor. In the event of any safety-related incident within the mine premises, the sole liability shall be of the bidder/contractor. Any negligence or carelessness towards safety may lead to immediate termination of the contract or awarded work at any stage of time.

- 18 The receiving bids with matching / common IP addresses with either bidder(s) / seller (s) or Buyer shall be out-rightly rejected and shall not be considered for further evaluation.**
- 19 Compensation in case of Accident:** The Company shall not be responsible for payment of any claim or compensation of any kind to the Contractor, his employee or any other third person/party/agency against claim or compensation of any nature whatsoever, arising out of any accident or any other unlawful act of the Contractual employee. The party shall be exclusively responsible for such payments of compensation, if any.
- 20 Compliance with Statutory provisions:** The contractor shall familiarize himself and fully comply with the provision of all the Acts/Rules/Regulation/By-Laws and orders of the Local authorities/Municipality/State Govt./Central Govt./DT O/RTO applicable to the worker, Mines Act, Payment of Wages Act, Motor vehicle Act, Workmen's compensation Act etc. and shall be fully responsible and liable for due observance of the same. The company shall have no responsibility/liability whatsoever on these accounts and the contractor shall fully indemnify the company against any claim/dispute, etc. arising out of the same. - 21** If the Company suffers any loss on account of damage to its property, due to any failure on the part of contractor or due to any act or omission or commission on the part of his representative/employees, the value of the same as assessed by the company, shall be recovered from the contractor's bill / security deposit. The decision of the company in this regard shall be final and binding to the contractor.
- 22** No escalation of rates shall be entertained on cost of spares, labour wages, POL or any other head.
- 23** For all disputes arising of this contract, the jurisdiction shall be in the Courts of Nagpur, Maharashtra

During the course of execution of work, Scope of deliverables from WCL shall be limited to only:

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs from the State of Bid Inviting Authority having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry / State of Bid inviting authority. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 7. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
