- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

Service provider obligations

1. The vehicle offered should be a commercial permit vehicle i.e., Number plate should have yellow background with black lettering. Owners must obtain the necessary commercial permits from the Regional Transport Office (RTO). The vehicle and its operator must posse ss special permits from the Regional Transport Office (RTO), as mandated by the Motor V ehicles Act, 1988. The bidder should offer the commercial vehicles registered in the name of proprietor or the company names only with uploading the requisite documents such as Registration Certificate, Insurance papers and PUC of the vehicle. Third party vehicles documents will lead to disqualification from bid.

- 2. The Service Provider shall undertake to indemnify the department against all damages/charges arisi ng on account of or connected with the negligence of the Service Provider or his staff or any person under his control whether in respect of accident/injury to the person or damages to the property of a ny member of the public or any person or in executing the work or otherwise and against all claims a nd demand thereof.
- 3. The service provider should be a proprietorship / partnership / registered firm/ company registered only in Kolhapur. Necessary proof of registration in Kolhapur should be submitted. Kindly note that the bids submitted by a proprietorship / partnership / registered firm / compan y registered outside Kolhapur shall be rejected.
- 4. Fuel and Repair & Maintenance expenses shall be borne exclusively by the service provider.
- 5. Preference will be given to bidder having experience of minimum 3 years of providing vehicle/s in Go vernment office. However, preference will be given to service providers with experience in Income T ax Department. The documentary evidence for each of the above should be enclosed along with self attested performance letter
- 6. In case quality of service by the Service Provider is found wanting, this Office may terminate the con tract after giving 15 days notice. In case of such termination, services of other empanelled Service Pr oviders will be utilized.
- 7. This Office will have the discretion to extend the period of contract or terminate the contract premat urely in case of unsatisfactory service.
- 8. Proof of payment of appropriate GST will be required to be submitted to this Office.
- 9. The contract of the interested bidder should not have been prematurely terminated by any Central Govt., State Govt or PSU office. The details of such information may be given to this office. The bidd er should give undertaking about any technical disqualification if any. Any suppressing of facts relate d previous experience should result in rejection of bid.
- 10. The bidder should own altleast 4 commercial vehicles in his name or his company's name. Proof of ownership to be submitted along with the bid. The bidder should offer the vehicles registered in the name of proprietor or the company names only.
- 11. Log book for daily running of vehicle is to be maintained properly and be signed by the officer/official using it.
- 12. Out of the total agreed monthly running distance of 2500 km of each vehicle, if the utilization of km per month is less than 2500 kms, the un-utilized number of kms shall be added to the next month o pening balance and so on for the succeeding months, of the concerned vehicle.

Before finalization of contract the condition of vehicle and driver's proficiency would be checked by conducting driving trials. If the condition is not satisfactory, the bid will be summarily rejected.

Term & Conditions of Vehicle provided by service provider

- 2. The drivers should be well conversant with the roads and routes of Kolhapur/ Ichalkaranji/ Ratnagiri/ Kudal / Pune. The operation and functions of the drivers shall be governed as per the Motor Vehicles Act and Rules.
- 3. The Driver provided by bidder must be properly dressed in white Shirt and pants.
- 4. The Driver must have knowledge of motor mechanism. The Driver should be able to remove minor-

defects in vehicle.

- 5. The drivers should always remain with the vehicle during the entire period of duty. In case of any ne ed, they should seek permission from the concerned officers.
- 6. The drivers should have a minimum experience of three years of driving, which should be verifiable from the date of issuance of his driving license.
- 7. The service provider shall provide name and address of the drivers. The drivers deputed for service to this Office should not have any Police records / Criminal cases (previous or pending) against the m. The service provider should make adequate enquiries about the antecedents of the drivers befor e deputing them for service to this Office. The Driver provided by bidder must submit a Police verification certificate.
- 8. A daily record indicating time and mileage for each vehicle shall be maintained in a log book which hashould be submitted to the concerned officer of this Office for scrutiny & payment of the bills. Unused Kms shall be carried forward to the next month.
- 9. It is compulsory for the driver to maintain Covid appropriate behavior. The driver should have the c ertificate of having at least two doses of COVID vaccine.

10. The driver should be easily available on mobile 24 X 7.

Only those service providers should apply who agree to unconditionally abide by the above terms a nd conditions. Conditional acceptance or proposing modification of any condition/s will invalidate the tend er/bid.
