2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

5. **Purchase Preference (State)**

Bid reserved for MSE from the State of Bid Inviting Authority: Procurement under this bid is reserved for purchase from Micro and Small Enterprises from the State of Bid Inviting Authority having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. 3. Bidders must have experience of a minimum of 3 years in providing similar service in government /PSU/ Autonomous organizations. Documentary proofs for the same shall be provided along with bid documents.

4. The bidder has to submit code of integrity affidavit regarding codes as mentioned in GFR 175 on stamp paper not older than 2 months

5.The CGCA reserves the right to terminate this Contract, in whole or in part, at any time during its currency, without assigning any reason thereof, by giving the Contractor a written notice.

6.The Contractor shall at all times avoid situations in which its interests conflict or could conflict with the interests of the CGCA. The Contractor shall immediately disclose to the CGCA any situation that may give rise to a conflict of interest during the execution of this Contract .In case such a conflict arises and is not resolved to the satisfaction of the CGCA, the Contract is liable to be terminated. The decision of the CGCA in this regard shall be final and binding.

7. Neither party shall be liable for any failure or delay in the performance of its obligations under this Contract if such failure or delay is due to causes beyond its reasonable control, including but not limited to acts of God, war, civil disturbances, strikes, lockouts, fire, floods, epidemics, pandemics, or government restrictions (hereinafter referred to as "Force Majeure").

8. The bid security (EMD) will remain valid for a period of 45 days beyond the final bid validity period. The bid security of unsuccessful bidders will be returned to them at the earliest after expiry of final bid validity.

9. The bid security will be refunded to successful bidders on receipt of performance security and will not be adjusted with performance security.

10. Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations

11. Any loss by the act/negligence of the contractor (outsourced person engaged through contract) will be adjusted from the performance security and the bills of the successful contractor.

12. The performance security will be refunded inter alia after receipt of the "No claim certificate" from the successful contractor (as per Annexure -24 Manual for procurement of goods).

13. No advance payment will be made to the successful bidder/contractor.

14. Payments to the successful contractor will be made on a monthly basis on receipt of the bill with satisfactory completion of contracted services for the month. Amount of uncompleted services/period will be subtracted proportionally from the bills received and will be paid accordingly.

15. All disputes arising out of or in connection with this contract shall be subject to the exclusive jurisdiction of the Courts at Delhi.

16. In case multiple bidders quote the same L1 price, the bidder automatically selected by the GeM shall be declared as the successful bidder, and the work shall be awarded accordingly.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and
- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
