- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. - 2. preference will be given to MSEs as Micro and Small Enterprises from the State of Bid inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 25 % of total quantity as defined/ decided in relevant policy. 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. # Special terms and conditions-Version:1 effective from 03-09-2025 for category Online UPS (?10 KVA) With Battery Conforming To IS 16242 (Part 1)

1. **1.** In addition to General Terms and Conditions of GeM, the following Special T&C shall be applicable with reference to Installation and Commissioning.

Note to Seller: Installation and Commissioning shall involve all the interconnections, any cabling between power source, switch boards within 3 metre range for input power and connecting Output power in the Scope of seller.

Note to Buyer: Buyer will ensure well ventilated/covered site/room having requisite power points/distribution board to provide input power to UPS as well as to take out power from UPS within 3 metre of the location of UPS placement.

Note: The above is indicative and any incidental requirement related to above responsibilities shall also be considered in the responsibilities of Buyer and Seller as applicable.

**2.** The type of battery shall comply with the relevant BIS/IEC standard. ( IS 15549/IS 13369 for Lead Acid Batteries and IS 16046 (Part 2)/IEC 62133-2 for Lithium-Ion Batteries.)

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Rate Contract

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The scope of supply shall include the Supply, Installation, Testing, and Commission ing of the Online UPS systems as per the bid specifications. The quoted price shall be inclusive of all components, accessories, software, cables, and installation materials r

equired for the complete functioning of the UPS units.

- 2. All supplied UPS systems must conform to relevant IS/IEC standards and comply wi th the technical specifications mentioned in the tender document. Products must be new, original, and from the OEM—no rebranded, refurbished, or counterfeit items will be accepted.
- 3. The bidder shall provide a bid-specific authorization letter from the Original Equip ment Manufacturer (OEM) at the time of bid submission.

The authorization letter shall include: • GeM Bid Reference Number • OEM Name, De signation, and Contact Details (email, phone, and address) • Confirmation that the bidder is authorized to supply, install, and service the quoted product.

- 4. If applicable, all UPS monitoring or management software must be installed, config ured, and demonstrated by the vendor. A report of successful installation and testing must be submitted for verification and payment processing.
- 5. The bidder shall ensure installation and commissioning of the UPS systems at the c onsignee's location within the stipulated time frame mentioned in the bid. Installation shall include battery setup, wiring, connection to load, and functional demonstration.
- 6. Bidders are required to upload all the required documents as per bid through GeM Portal only.
- 7. Bidders should have registered with GST and PAN (Documents to be uploaded)
- 8. Bidder should have Past work experience with the same type of services.
- 9. Producing OEM Certificate from the Manufacturers is compulsory for the product wi th specific Bid Number.
- 10. Break down calls should be attended immediately during warranty period, including public holidays and Sunday. In the event of a malfunction or service call, the vend or must respond within 24 hours and resolve the issue within 2 working days from the time of complaint registration.
- 11. The following documents must be uploaded at the time of bid submission: Product Datasheet and Technical Brochure OEM Authorization Letter Compliance Certificates (such as ISO, BIS, RoHS, Energy Star, or equivalent) Warranty Declaration Service Center Proof Past Performance Certificates (preferably from Government/PSU clients)
- 12. The bidder shall guarantee that the supplied UPS systems will meet the rated load capacity and backup duration under specified environmental conditions. Performance verification shall be carried out at the consignee's site during installation.
- 13. The terms and conditions as mentioned in the dated 21/12/2004 & G.O.Ms.No.65 2/DIT/DI/ 2025/ dated <math>15/05/2025 of the Directorate of Information Technology, Pud ucherry, must be followed
- 14. The tender inviting authority has the right to reject any or all bids without assigning any reasons thereof.

- 15. The bidder and OEM service Provider should have a full-fledged office in consigne e's location is compulsory (Proof of GST and Trade Certificate License should be enclosed with the bid.)
- 16. Onsite Engineer should be deployed on call basis during warranty period must en sured. Local contact numbers to be provided for attend calls.
- 17. The Seller should install the items in the consignee stated location and should be ar the cost of installation.
- 18. ATC acceptance Certificate must be given in the respective seller letter head alon g with ATC required documents
- 19. The OEM/Authorized dealer participating in the bid should submit the model and make of the UPS and Battery along with the specification.
- 20. The OEM should have at least 10 years of experience in the field of manufacturing and supply of Online UPS, proof of the same should be submitted.
- 21. GST Certificate should be submitted for OEM Service center in consignee's locatio n.
- 22. The payment will be settled after the completion of whole installation works.
- 23. Battery make should be reputed brand like Exide, Amaron.
- 24. The warranty for **UPS** 3 years and **Battery** warranty 2 years.

# अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove;
