1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Inspection

3. Sample Clause

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

samples for Buyer's approval, within 5 days of award of contract. Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 5 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.

Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the

sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.

4. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

5. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

Addl Terms & Conditions

(1) **Inspection of Store:-** The advance sample/ consignment will be inspected by a board of officers detailed on behalf of accepting authority. The advance sample/consignment will be checked against specifications in GeM contract and sample held with consignee, i.e. 14 Corps OMC, Leh, c/o 56 APO.

(2) **Rejected Stores:** In case of entire consignment /part consignment is rejected by the accepting authority, it is responsibility of the supplier to collect the rejected quantity from consignee loc within 15 days of intimation of rejection. The cost involved will be borne by the supplier.

(3) **Supply of rejected quantity:** In case of entire consignment/part consignment is rejected by the accepting authority, it is the responsibility of the supplier to supply the rejected quantity within the delivery period. No extension of delivery period will be granted on grounds of rejection.

(4) **EMD Deposition:-** The physical EMD must be received at Leh (consignee loc) before opening of technical bid. A softcopy of the EMD should also be uploaded along with bid documents.

(5) **EMD Exemption:** EMD will be exempted for Micro and Small Enterprises (MSEs) and the firms registered with concerned Ministries/ Departments, only if the firm is the production/ manufacturing unit of the offered product and not the re-seller/trader. Exemption will be done on producing relevant documents along with the bid certifying the above mentioned fact. Responsibility of establishing the fact that firm is the production/manufacturing unit of the offered product in the bid, lies with the participating firm itself.

(6) **MSE Cert:** UDYAM registered MSE certificate alongwith DGQA/ COA certificate. In case MSE is a manufacturer, the details of manufacturing with respect to the required item may be furnished.

(7) **MIL Cert.-** Details as per Para 9 Of DPIIT Order No P-45021/2/2017-PP(BE-) dt 16 September 2020 mentioning place of value addition of local content alongwith Bid Number to be uploaded.

(8) **Exemption from Experience and turnover criteria MSEs and Startups:-** Exemption to be given only on producing relevant documentary evidence certifying if the firm is the production/manufacturing unit of the offered product and not the re-seller/trader

(9) **Quality/Brand:-** Good Quality Product from reputed and known brands (IS Certification, where applicable).

(10) **Advance Sample:-** After award of contract advance sample to reach consignee within 05 days from the date of placement of SO.

(11) **Warranty period:-** Warranty of minimum 18 months will be provided from the date of final delivery of stores.

(12) **Delivery location:-** Stores to be delivered at consignee loc. i.e, 14 Corps Ord Maint Coy, c/o 56 AP O, Leh, Ladakh

(13) **Liquidated Damages (LD) Clause:** In the event of delay in delivery beyond the stipulated period, Liquidated Damages (LD) shall be levied as per the provisions of the Defence Procurement Manual (DPM) 2009. The applicable LD shall be 0.5% of the undelivered goods/services per week or part thereof, subject to a maximum of 10% of the total contract value. The imposition of LD shall be without prejudice to other remedies available to the Buyer, including termination of the contract at the risk and cost of the Supplier. Any request for waiver or reduction of LD shall be subject to approval by the Competent Financial Authority (CFA) as per DPM 2009 guidelines.

(14) **Registration with DPIIT :** Registration of the participating firms with DPIIT is mandatory as per addendum to Rule 144 (XII) of GFR. Bidder (Incl Indian) having commercial argu with any entity from countries which share land borders with India also need to register with DPIIT. Any such document wrt country of Origin/Country of manufacture/Bill of Mtr/ Supplier visibility/ OEM details may be asked for during the technical evaluation stage at any stage of procurement to verify the claims.

(15) **Procurement from Countries Sharing Land Border with India:** Bidder from a country sharing land border with India is required to submit certificate of registration as per Govt/Min of Finance (Department of Expenditure) OM No F7/10/2021-PPD dt 23 Feb 2023 regarding amdt to Rule 144 (XI) of the GFR 2017 and order (Public Proc No 4) No F7/10/2021-PPD (1) dt 23 Feb 2023 regarding restriction under Rule (XI) of GFRs 2017.

(16) **Debarred/Blacklisted Firms:-** Bid submitted by firm/ entity debarred/ blacklisted by the govt/ Defence forces/ PSU/PMFs/Police/ any recognised agency will not be considered for evaluations. Vendors are required to submit and undertaking duly verified by the registered CA.

(17) **Visit of Factory Premises & Verification of Products till component level:** During the technical evaluation, vendor may be called for submission of minimum four samples of the products being offered by the vendor on 'NO Cost No Commitment' basis within fourteen days of the commencement of TEC, wherein TEC may undertake inspection down to the components/ chip level of any of the random products submitted or visit to factory premises of the OEM/ Supplier or both to comply with Govt/ Min of Finance (DOE) OM No F7/10/2021-PPD dt 23 Feb 2023 regarding amdt to Rule 144 (XI) of the GFRs 2017 and order (Public Proc No 4) No F7/10/2021-PPD (1) dt 23 Feb 2023 regarding restrictions under Rule 144 (XI) of GFR 2017.

(18) **Country of Origin** Country of Origin of the equipment & components will be explicitly specified: The invoice trails to ascertain the country of origin may be verified during the technical evaluation.

(19) **Testing/Eval of Ruggedness:-** In case of proc of electro-optical eqpt like day sight, TI Sight, Mono cular/ Binocular, Spotter Scope etc where the NCOR specifies IP rating (IP 65/67), MIL Std 81 OG, JSS 55555 or equivalent standard, 'Drop Test & Water Resistance Test' will be conducted physically.

(20) **Delivery Acceptance Certificate** The items shall be delivered to the consignee's location in Leh. Delivery to any other location will not be accepted. The firm shall submit a separate certificate confirming compliance.
