Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

4. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

5. Purchase Preference (State)

Buyer Added text based ATC clauses

1. Retention of Resources: The User Department reserves the right to retain a minimum of 50% of the resources deployed under the ongoing contract, should such retention be deemed necessary, as per the requirements of the User Department.

2. Surprise Inspections: The contracting party is intimated that surprise inspections will be conducted by this office to verify the availability and presence of security guards at the designated points, both after working hours and on closed holidays. The Contractor is required to ensure that the deputed security staff is made aware of such inspections.

3. Corrective Actions for Deviations: In the event of any deviation, lapses, or instances of non-availability of the security guard during an inspection, the Contractor shall, without fail, take immediate corrective actions, including but not limited to the replacement of the security staff on duty, to ensure compliance with the terms of the contract.

4. Change of Security Guards: The Contractor shall not change any security guard assigned to the User Department without prior intimation. Furthermore, repeated or unauthorized changes to the security staff, without the prior written approval of the Competent Authority within the User Department, shall not be permitted.

5. Uniform and Identification: All deployed guards must be in proper uniform, with clearly visible identity cards at all times during duty hours. Any guard found without proper uniform or ID shall be considered absent, and the same will attract penalties.

6. Training and Fitness: The Contractor shall ensure that all security personnel are adequately trained in basic security protocols, fire safety, first aid, and emergency response. All guards must be physically and mentally fit.

7. Behavior and Conduct: Security personnel must maintain discipline, professional behavior, and courteous conduct at all times. Any misconduct, negligence, insubordination, or inappropriate behavior reported against any guard shall result in immediate removal and substitution of the said guard at the Contractor's cost.

8. Replacement of Unsatisfactory Personnel: The User Department reserves the right to reject any security personnel found to be unfit, negligent, or unsatisfactory in performance. The Contractor shall replace such personnel within 24 (twenty-four) hours upon receipt of such communication.

9. Record Maintenance: The Contractor shall maintain duty rosters, attendance registers, incident logs, and other necessary records at the site and shall produce them for inspection whenever required by the User Department.

10. Penalties for Repeated Non-Compliance / Non-Adherence: The User Department reserves the right to impose penalties or take further action, including the termination of the contract, in accordance with the conditions stipulated in the contract in case of any failure by the Contractor to adhere to or repeatedly non-comply with the provisions set forth in these Terms and Conditions.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
