1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to

minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

3. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

4. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Nil Deviation Clause:

The sellers who participate in current Tender are deemed to have fully accepted all Terms & Conditions, Technical Specifications, Data Sheets, Drawings, Quality Plans, Buyer Added Bid Specific Terms and Condition s given in Bidding Documents, read in conjunction with Amendment(s)/ Clarification(s)/ Addenda/ Errata (if any) issued by the Buyer prior to op ening of Techno-Commercial Bids, and the same are supposed to have been taken into consideration while making their Techno-Commercial B id & Price Bid.

1. Further it is construed that no deviation has been taken by the seller in this regard. In case any documents/ details/ catalogues are found to ha ve been submitted by the bidder along with its bid, which is in contrave ntion to buyer's bidding documents inter-alia including technical specification, those will not be taken into cognizance. If any deviation is observed in the bid, bidder shall have to withdraw such deviations; failing which bid shall be liable for rejection.

Bidder/supplier shall have no right to contest the same in case supplied material is rejected due to deviation with respect to tender specificatio n.

Bids by vendors not meeting this criterion shall be rejected during technical evaluation.

MSE preferences:

In case of procurement of goods / services, preferences to MSEs whose quoted prices are within L1 (non-MSEs) +15% range (subject to matching of L1 price) will be given in the following order:

Conflict of Interest

- (A) A bidder shall not have conflict of interest with other bidders. Suc h conflict of interest can lead to anti-competitive practices to the d etriment of Employer's interests. A bidder may be considered to ha ve a conflict of interest with one or more parties in this bidding proc ess. if:
 - a) they directly or indirectly control, or are controlled by or are under common control of another entity: or
 - b) they have the same legal representative/agent for purposes of their bids; or
 - c) they have relationship with each other, directly or through common third party(ie s), that puts them in a position to have access to information about or influence o n the bid of another Bidder; or
 - d) Bidder and/or any of its allied entity(ies), which directly or indirectly control(s) or is(are) controlled by or is(are) under common control of another entity, has(ve) p articipated as a consultant in the preparation of the design or technical specificati ons of the contract that is the subject of the tender; or
 - e) Bidder participates in more than one bid in this bidding process.
 - f) In cases of agents quoting on behalf of their principal manufacturers/service pr oviders, one agent cannot represent two manufacturers/service providers or quot e on their behalf in a particular tender enquiry. One manufacturer/service provide r can also authorize only one agent. There can be only one bid from the following:
 - The principal manufacturer/service provider directly or through one Indian ag ent on his behalf; and
 - ii) Indian/foreign agent on behalf of only one principal.

For the purposes of this clause the term 'control' shall have the following meaning:

"Control" shall include the right to appoint majority of the directors or to control the management or policy decisions exercisable by a p erson or persons acting individually or in concert, directly or indirectly, including by virtue of their shareholding or management rights or shareholders' agreements or voting agreements or in any other manner.

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
