- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Forms of EMD and PBG

Bidders can also submit the EMD with Payment online through RTGS / internet banking in Beneficiary name

6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Railway Administration will have right to terminate the contract as per extant of GeM standard General Condition of Contract.
- 2. The vehicles is required at Senior Section Engineer (P.Way) Damoh east, Senior Section Engineer (P.Way) Damoh west. And Senior Section Engineer (P.Way) Salayia under Assistant Divisional Engineer, Damoh sub division for transportation of material to various station and sections for a **period of 12 Months**.
- 3. Vehicle will have to be available according to requirement and demand for the use of Railway Administration from 00.00 to 24.00 Hrs. from the date of the acceptance letter. The vehicle will be permitted to be withdrawn for servicing and maintenance etc. only after an alternative vehicle should be made available during that period.
- 4. Vehicles should be in good working condition and capable to run on kachcha road also.
- 5. The vehicle should be self-starting in good running condition.
- 6. If vehicle does not turn upon on requirement /demand, 3 times of normal rate per day calculated will be deducted from contractor's bill.
- 7. Petrol/Diesel, mobile oil, toll tax, entry tax, nakha etc. for the use in the vehicle along with the driver from the time of hire shall be provided by owner of vehicle at his own cost including the wages of staff.
- 8. The logbook will be filled by SSE In-charge on daily basis with signatures.
- 9. The bill will be verified by concerned ADEN/DMO before sending to DRM (W) Office, at Jabalpur.
- 10. The vehicle shall move according to the instruction of concerned ADEN/DMO or his authorized representative.
- 11 Railway Administration shall not be responsible for any accident, damage etc . to the vehicle during the period of hire.
- 12. In case vehicle goes out of order an alternate vehicle must be arranged with in a reasonable time not exceeding one day. All relevant documents of the alter nate vehicle to be made available before bringing vehicle for run. This shall be c hecked by SSE In-charge & concerned ADEN/DMO.
- 13. All documents including competency of Driver must be available on the truc k.

14. The expenditure on maintenance, comprehensive insurance, registration and road tax etc. shall be borne by the contractor.

- 15. Rates quoted shall be valid throughout the period of contract. Any variation in fuel rates shall not effect contract agreement, hence contractor will have to work on same rates. The validity of contract will be one year from date of acceptance.
- 16. Calculation for average Kms will be on monthly basis.
- 17. The vehicle so offered shall not be older more than 2023.
- 18. All messages will be conveyed to ADEN DMO.
- 19. Contractor should have a good communication system available with the driver and himself.
- 20. In case of misconduct/lack of communication by driver a penalty of Rs. 1000 /- may be leived on each as, duly certified by SSE (P.Way) and countersigned by ADEN.
- 21. The GST rates will be applicable as per the Govt. Guidelines.
- 22. Billing for the work will be done upon renewal submission of occupancy register. site draw books, measurement register, EPF, ESIC payout details recovery certificate and other relevant record duly signed by by Engineer's representative for the billing period day with recovered/offline bill GST voucher.

7. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

8. Service & Support

In the event where the distance travelled exceeds the monthly usage variant, amount will be paid for additional Kms as per schedule. Similarly, the unused Kms in a particular month as against the minimum guaranteed usage variant will be carried forward to the next month and additional Km if any in the next month shall be adjusted against this. However, the payment for the selected usage variant in a month will be paid every month." Further, the unused Kms in a particular month shall not be carried forward or adjusted beyond 6 months

9. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

10. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
