- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. - 2. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

If needed the bidder/supplier will be informed of the date and venue of the d emonstration of quoted products at their cost. Non-submission of a sample/unsuccessful demonstration will disqualify the bidder in the technical bidding process and the financial bid of the bidder will not be opened
- 12. The Net Worth of the OEM should be positive as per the last audited financial statement.
- 13. Bidder should presentRs.100/-affidavit of non-blacklisting in India before the bid end date and should n ot be more than 90 days old.
- 14. The Bidder must have been working in any government institution department for at least 3 years.
- 15. If the uploaded document is not Readable then the seller will be Disqualified
- 16. L1 Bidder have to give affidavit that all the civil and Fixing work will be Measurement and Bills will be Present by J.E of ULb after that Payment will be done if not followed that ATC. Contractor will be Completel y responsible
- 17. The bidder must provide No Dues Certificate issued by Nagar Panchayat Parshadeur Raebareilly.
