1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Non-submission of a sample/unsuccessful demonstration will disqualify the bidder in the technical bidding process and the financial bid of the bidder will not be opened.
12. The Net Worth of the OEM should be positive as per the last audited financial statement.
13. Bidder should present Rs.100/-affidavit of non-blacklisting in India before the bid end date and should not be more than 90 days old.
14. The Bidder must have been working in any government institution department for at least 3 years.
15. If the uploaded document is not Readable then the seller will be Disqualified
16. L1 Bidder have to give affidavit that all the civil and Fixing work will be Measurement and Bills will be Present by J.E of ULb after that Payment will be done if not followed that ATC. Contractor will be Completely responsible
17. The bidder must provide No Dues Certificate issued by Nagar Panchayat Parshadeur Raebareilly.
