### 1. **PERIOD OF CONTRACT**

2.1 Contract will be valid for 24 (twenty four) months from the date of acceptance.

2.2 Railway reserves the right to close the contract as per extant norms.

### 2. **The contract shall supply vehicle in good and perfect working condition: utility**

vehicle shall be maintained in good condition throughout the period of the validity of the contract to ensure satisfactory service under the contract. Railway shall have the right to reject the vehicle if not found suitable as per above.

3. Tenderer shall necessarily indicate following, regarding the offered vehicle.
  - (a) Type of utility vehicle (Maruti Suzuki Ertiga, Mahindra XUV300, Mahindra Scorpio, Mahindra Bolero, Tata Sumo or similar segment as per Gem)
  - (b) Year of model (not earlier than year 2023)
4. Contractor shall quote rate as per "Scope of Work" as mentioned in the Bid. The rate shall include the following
  - (a) All maintenances expenditure of the vehicle i.e. major and minor repair required for good running of the vehicle, cleaning, lubricants, all consumable other than diesel which shall be included as per Para (2) below
  - (b) Rate shall include cost of diesel/petrol for running of vehicle as per scheduled items for the duration of contract.
  - (c) Rate shall include salary and other charges of two drivers including EPF, ESIC etc. to be paid to the drivers

7. The Head Quarter of the Vehicle shall be at **Assistant Divisional Engineer (South) Satna.**
8. Availability of vehicle to be ensured throughout the validity of Contract (24 X7)
9. Contractor shall maintain a record for daily meter reading which shall jointly signed by the Railway official using the vehicle and driver of the vehicle. It will be the responsibility of the driver of the vehicle to ensure that the daily kilometre reading are properly filled in and any over writing/cutting should be got authenticated by the officer using the vehicle.
10. Contractor shall ensure that enough fuel is available in the Vehicle all the time, Contractor shall ensure that all the meters particularly KM, fuel and devices of vehicle are in Proper working condition. In case any defects got developed and are pointed out by Railway authority, repairs and replacement necessary should be carried out immediately by the contractor at his own cost. The contractor shall ensure that the vehicle is available every day. In case of failure to provide a vehicle, a penalty of double the daily rate shall be levied for each day deduction

n for weekly rest also be done at daily rate basis. Daily rate for this purpose shall be calculated as. Monthly charges accepted/30. Contractor shall provide a good condition spare wheel and tools kit with the vehicle. The vehicle shall normally be used in **ADEN (South) Satna** on all type of road i.e. PuccaKutchha service road etc and depending upon the requirement of **ADEN (South) Satna**.

11. If vehicle runs more than the 1600 Km in a month then for extra km, charges per km will be calculated as per GeM formula : Extra per km charges - Monthly package cost divided by no. of kms in monthly package multiplied by factor 0.5 in case of normal service and 0.4 in case of 24x7 service.
