- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
- 3. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 4. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The supplier will ensure that in case of absence of driver on some definite day, the matt er will be informed in advance and a suitable driver will be provided in place of regular driver. Also, no change of regular driver should be made unless for urgent reason, with due ad vance intimation.
- 2. In case of non-reporting of the contracted vehicle on some day for some emergency reas on, the supplier will ensure that a vehicle of same level will be duly provided within time.
- 3. The driver appointed should have geographical knowledge of the areas where he will be required to run the vehicle, including of district Mandi, Kangra, Shimla of Himachal Pradesh and Chandigarh. He should also be habituated to drive in hilly terrain. The residence or pla ce of regular residing of such Regular driver to be deputed must be located, aerially distan ce wise, within 15 km from the Income-tax Office, Mandi (H.P.). Documentary evidence in s upport of address to be attached is **Additional Doc 1 requested in ATC :-copy of Aadh ar Card or Rent agreement).**

There must be a duly signed express consent by such driver regarding intention to continu e to work for the intended period of contract on behalf of such bidder to the buyer. **Additio** nal Doc 2 requested in ATC:- (Copy of duly signed consent letter between the bi

dder and the driver must be attached).

Additional Doc 3 requested in ATC:- Copy of driving license of the driver must be att ached. The bidder can, if so desire provide a list and documents of more than one driver at his discretion and attach documents accordingly.

- 4. Maximum amount payable is Rs. 50,000/- + GST per month.
- 5. In case of non-reporting of vehicle on any day, amount upto double of pro-rata charge fo r each day can be deducted from the monthly charges, if reason for the same cannot be su bmitted upto the satisfaction of the buyer.
- 6. Among the vehicles chosen for the bid, preference will be given to those which are newe r, have more safety features/ space/comfort/drive ability in hilly terrain etc.
- 7. That during the contract period if the vehicle is seized/detained/impounded by the police or any authority for any reasons whatsoever, it will be at the sole risk/responsibility of the service provider.
- 8. The vehicle will be parked either in the office or at some place selected by the buyer. Fro m such parking place, normally the driver will commute to and fro till his/her staying place on his own. However, if requested and such request is accepted by the buyer, the driver m ay take the vehicle to such staying place but the distance between the parking place and s uch staying place will not be counted in the usage kilometers of the vehicle for charges pur pose.
- 9. The Agreement shall come to an end either on completion of the Contract Period or shall be terminated for the following reasons:
 - a) Mutual consent: The contract may be terminated based on mutual consent in c ase the services are no longer required. Termination based on mutual consent will n ot attract any penalties or shall not be liable for any extra payments other than pay ment of invoices raised till the time of termination including notice period.
 - b) Breach of contractual obligations: Any incidents considered as the breach of contract will result in immediate termination of services. The Buyer shall have the right to

terminate the Contract effective immediately by giving written notice to the Service Provider if, the Service Provider breaches a material provision of this Contract where that breach is not capable of remedy; or if the Service Provider breaches any provisi on of this Contract and fails to remedy the breach within 14 days after receiving notice requiring it to do so. Breach of SLAs: The contract may also be terminated if:-

- i) The cumulative penalties rise to 10% of the contract value.
- ii) Repeated breach of any SLA beyond 3 instances as per buyer discretion. H owever, termination of this Contract shall not affect any accrued rights or re medies of either party.
- 10. The driver will maintain logbook of journeys performed and get it countersigned by the user on regular basis.
- 11. The service provider will ensure that the vehicle provided should have comprehensive i nsurance cover and the buyer will not be responsible of any damage whatsoever to the vehicle/driver. The insurance charges will be borne by the service provider.
- 12. The expenditure incurred on account of repair of the vehicle, wear and tear, replaceme nt of batteries and tyres shall be borne by the service provider.
- 13. The vehicle should be always kept in clean and hygienic condition. Servicing of the vehicle must be done at regular intervals as per the schedule of the manufacturer for such vehicle as well as, as and when required after long/continuous use, if any.
- 14. The service provider will also comply with all the safety rules and regulations as prescribed by the government from time to time.
- 15. The tax on source will be deducted from the payments made to the service provider as per existing provisions of Income tax and GST. The contractor will have to submit the proof of deposit of GST claimed, either quarterly or on demand by the buyer.
- 16. The driver will be provided by the service provider and should be a person of integrity, f ree from infectious diseases. The driver must be literate and well behaved and must posses s valid driving license and should have three years of experience and must carry all necess

ary documents. The driver should have a valid mobile number that should be reachable at all times.

- 17. If the performance of the service provider or the driver provided by him is found to be d issatisfactory and even after request, the performance is not improved or the driver is not c hanged up to the satisfaction of the buyer, the contract may be terminated at any time by t he buyer on a 3 days notice.
- 18. The contract can be terminated by either party by giving 30 days notice in advance, in cases other than that referred in Para 16 above.
- 19. The driver should be paid within 10th day of each month for the previous month, irresp ective of actual date of receipt of monthly bill payment by service provider.
- 20. The vehicle must be fitted with FAST Tag. All the bills of toll payment, parking charges, night charges etc. is included in Rs. 50,000/- + GST per month.
- 21. Whenever the vehicle goes for outdoor duty outside normal routine duty for a day or m ore, the driver must be paid in advance for expenses of food & lodging. It will be duty of th e officer using the vehicle to inform the service provider in advance regarding such outdoor official tours and it will be duty of the service provider to confirm that officer about paymen t of such advance to the driver.
- 22. Contract can further be extended upto 1 Year based on the satisfaction of the buyer considering service provided by the seller.
- 23. Certificate of Undertaking regarding agreement with Additional Term and conditions mu st be submitted.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.Proof for Past Experience and

Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws /

acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
