1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

the **Additional Terms and Conditions:**

1. The bidders have to quote rates for supply and distribution of grocery items for 149 AWCs under ICDS Project, Rangat.

2. The tenders will have to bid for all the items and not in parts inclusive of all applicable taxes.

3. The rate(s) quoted should be strictly for free delivery at each AWC and will be valid and operative for supply orders issued on or before or up to 12 months or till the next tender is finalized.

4. The L1 bidder will be arrived at on the basis of the total value wise evaluation of the amount quoted for total amount of all the items in the bid and not as per the rate quoted for each items separately.

5. The quantity of SNP articles may vary on addition and deletion of beneficiaries in each month. Random testing of the quantity and quality of items supplied by the L1 bidder to the AWCs shall be done by an appropriate authority authorized by Directorate of Social Welfare.

6. Every month Anganwadi wise supply order will be issued to the supplier to supply in the respective Anganwadi Centre's.

7. The rates quoted by the firms for the items should be final inclusive of all taxes/ charges along with GST as applicable.

8. The successful bidder will have to enter into an agreement with the department for successful execution of the contract.

9. In case the firms fail to supply the items within the delivery period stipulated No of days liquidated damages

ged charge will be charged @0.5% per week to a maximum of 5% on the total cost of supply order, which will be deducted from the final payment and in case the firm fails to supply the items, the Performance Security of the firm will be forfeited to Government account and other action as deem fit will also be taken against the particular firm.

10. The Grocery Items supplied by the L1 supplier should meet the standard of FSSAI (Food Safety and Standards Authority of India).

11. It is the sole responsibility of the L1 supplier to deliver the Grocery items in good condition. If the Grocery items are found damaged, stale, substandard or low quality then the same should be replaced immediately with fresh items by the supplier without any additional cost to the buyer. Failing to replace the items in the stipulated time the L1 supplier, may be black listed and the agreement will be terminated without any notice to them.

12. Supply order, in respect of Grocery items, shall be issued by the Child Development Project Officer or any other authorized official of the department on monthly basis for supply of Supplementary Nutrition as per the registered beneficiaries to the specified Anganwadi Centre's as per the rates accepted by the office of the CDPO.

13. The L1 supplier has to deliver grocery items to the concerned Anganwadi Centre's under each project of ICDS within stipulated No of days from the date of issue of supply order.

14. The L1 Supplier shall submit printed bills in triplicate

ate in respect of items supplied to Anganwadi Centre within 15 days after the supply of items along with supporting documents like delivery challan etc.

15. The bills will be settled by the Child Development Project Officer subject to the fulfillment of terms and conditions. The required documents like GST number, PAN Card number etc. may be submitted along with bills, if required. They will be required to produce documents like PAN Card, GST Number, Account Number etc. for facilitation of payment if these documents are presently available scanned copy of the same may be uploaded as mentioned at Point No. 17.

16. The contract shall be initially for 12 months from the date of acceptance.

17. Necessary documents for the qualifying criteria:

a) Scanned copy of MSME certificate in relevant category if registered under MSME for the purpose of EMD exemption.

b) Scanned copy of EMD other than MSME registered organizations.

c) Copy of proof of recognizing SHGs issued by the Rural Department, A & N State Cooperative Bank, or any other Govt. recognized Agency (Applicable for SHGs).

18. Upload the scanned copies of other documents which are not mandatory.

3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
