1. Battery serial number list to be furnished by the seller along with the supply of the battery to the buyer.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the

additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. - 5. The bidder shall be solely responsible for any damage or loss occurring during the removal, handling, tr ansportation, or installation process. All such work shall be performed by trained personnel following prop er safety standards.
- 6. The bidder shall furnish an undertaking from the Original Equipment Manufacturer (OEM) stating that th e supplied batteries will carry a minimum warranty of **three (03) years**. The OEM shall also guarantee **re placement of defective batteries within the warranty period of three years** at no additional cost t o the purchaser.
