- 1. Preference to Make In India products (For bids > 200 Crore) (can also be used in Bids < 200 Crore but only after exemption by competent authority as defined in Deptt of Expenditure OM dated 28.5.2020): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. ELIGIBILITY CRITERIA

I. FINANCIAL CAPABILITY:

The financial Turnover of the tenderer in any of the last 3 Financial Year ending on 31st March 2024,

exclusive of all taxes and duties shall not be less than should not be less than Rs 2.68 Crores.

In support of eligibility w.r.t. financial criteria, tenderers are required to submit self-attested copies of the audited Profit & Loss Account and Balance Sheet (bearing membership no. & Firm Regn. No. of the chartered Accountant) for the last three financial years ending on 31.03.2024 viz. 2021-22, 20 22-23 and 2023-24. The documents shall bear Unique Document Identification Number (UDIN).

II. EXPERIENCE CRITERIA:

- a) Tenderer should have successfully completed similar orders during any one of the last five years e nding last day of the month previous to the one in which tenders are invited, exclusive of all taxes and duties, should be either of the following:
