- 1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
- 2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents
- 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Registration: The Bidder should be registered with the Income Tax, Goods and Service Tax. In proof of h aving fully adhered to minimum eligibility criteria as mentioned above, attested copy of PAN, GST Registration shall only be acceptable
- 2. Clearance: The Bidder should also have clearance from GST, and Income Tax Department. Relevant pro of in sup port shall be submitted. In proof of having fully adhered to minimum eligibility criteria as mention ed above attested copy of ITR and GST/ Service Tax Return for the last three financial years shall only be a cceptable.
- 3. Experience: The Bidder should have at least 03 years of experience for supplying goods and services in I ndian C 5 / 9 oast Guard, Ministries / Departments under Government of India. In proof of having fully adhe red to minimum eligibi lity criteria as mentioned above, attested copy of work orders along with work com pletion certificates / ongoing wor k certificates issued by the Indian Coast Guard, Ministries / Departments under Government of India shall be accept able.
- 4. Turnover: The Bidder should have minimum gross turnover in the similar business of providing supply of items a s per the bid document. In proof of having fully adhered to minimum eligibility criteria as mentione d above, attested copy of the audited balance sheets (audited by Chartered Accountant) for the completed three financial year i.e. 20 21-22, 2022-23 and 2023-24 shall only be acceptable.

- 5. Self-Declaration: That bidder has not been suspended or blacklisted by any Unit/ Office of Indian Coast Guard, any other PSU or Govt. Agency and submit a declaration as follows: "I/We hereby declare that I/we have not been Banned/Suspended/Blacklisted or de-listed by any PSU/Gover nment Department/ Financial Institution / Court." In case, the declaration is found incorrect/ false at any later stage, the tender is liable t o be rejected, the co ntract shall be closed without any further notice and Incident will be raise as per GeM Terms and Conditions.
- 6. Paying Authority: No advance payment will be done, payment will be made post completion of supply/work thr ough JCDA(Navy), Kolkata through online mode only.
- 7. Firms should fill the certificates duly attached in the ATC and upload along with the other bid documents for tech nical evaluation. Firms falling to do so are liable for rejection. ATC required as follows: "I/We hereb y declare that I/we would supply as per sample provided by Buyer. In case, the declaration is fo und not su bmitted the bidder are disqualified at technical stag of this bid". 8. Firms not replying to queries based on t echnical bids within the specified time will be rejected. 9. The firm should produce valid GST Certificate an d MSME certificate of State of Consignee i.e West Bengal only. Bi dders providing proof of registration in W est Bengal will only be qualified during technical evaluation. 10. Exemption: If MSME/Start up firm want to exempt in BID turnover and experience, the bidder must submitted the self declaration for exemption. 11. Bidder should have propervendor code and should submit the documents likePAN Card, GSTIN, cancelled c heque, NEFT mandate duly certified by bank. 12. Buyer reserves all the rights to cancel the bid at any time and any stag of bid without specifying the reasons. 13. In the matter of any dispute the decision of the buy er of the organisation will be final. 14. The firm should enclose Valid Registration Certificate and same should be submitted along with technical bids. 15. Non-submission of any of the information/ documents in the format attached with this proposal shall result in disqualification. 16. The quote for items should be as per specification mentioned in bid requirements.
- 17. The bid should be submitted as per specification mentioned in bid, if any mismatched in specification in bid doc uments the bidder are disqualified at technical stag of bid.
- 18. ATC as per specification to be attached.
- 19. Agents/Agency Commission: The Seller confirms and declares to the Buyer that the Seller is the origina I man ufacturer of the stores/provider of the services referred to in this Contract and has not engaged any i n dividable or firm, whether Indian or foreign whatsoever, to intercede, facilitate or in any way to recomm end to the Government of India or any of its functionaries, whether officially or unofficially, to the award of the contract to the Seller; nor has any amount been paid, promised or intended to be paid to any such ind ividual or firm in respect of any such interce ssion, facilitation or recommendation. The Seller agrees that i f it is established at any time to the satisfaction of the Buyer that the present declaration is in any way inc orrect or if at a later stage it is discovered by the Buyer that the Seller has engaged any such individual/fir m, and paid or intended to pay any amount, gift, reward, fees, commission or consideration to such perso n, party, firm or institution, whether before or after the signing of this contract, the Se ller will be liable to r efund that amount to the Buyer. The Seller will also be debarred from entering into any supply Contract wi th the Government of India for a minimum period of five years. The Buyer will also have a right to consid e r can collation of the Contract either wholly or in part, without any entitlement or compensation to the Sell er who s hall in such an event be liable to refund all payments made by the Buyer in terms of the Contract along with interes t at the rate of 2% per annum above LIBOR Rate. The Buyer will also have the right to r ecover any such amount fro m any contracts concluded earlier with the Government of India.
- 20. Liquidated Damages: In the event of the Seller's failure to submit the Bonds, Guarantees and Documen t s, su pply the stores/goods and conduct trials, installation of equipment, training, etc as specified in this contract, the Bu yer may, at his discretion, withhold any payment until the completion of the contract. The BUYER may also deduct f rom the SELLER as agreed, liquidated damages to the sum of 0.5% of the contract price of the delayed/undelivered stores/services mentioned above for every week of delay or part of a w eek subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of d elayed stores.
- 21. Termination of Contract: The Buyer shall have the right to terminate this Contract in part or in full in an y of t he following cases: (a) The delivery of the material is delayed for causes not attributable to Force Majeure for more than (03 m onths) after the scheduled date of delivery. (b) The Seller is declared bankrup t or becomes insolvent. (c) The delivery of material is delayed due to causes of Force Majeure by more than (01 month) provided Force Majeure clause is included in contract. (d) The Buyer has noticed that the Sel ler has utilised the services of any Indian/Foreign agent in getting this contract and paid any commission to such individual/company etc. (e) As per decision of the Arbitration Tribunal.
- 22. Notices: Any notice required or remitted by the contract shall be written in the English language and may be de livered personally or may be sent by FAX or registered pre-paid mail/airmail, addressed to the I

ast known address of the party to whom it is sent.

- 23. Amendments: No provision of present Contract shall be changed or modified in any way (including this provisi on) either in whole or in part except by an instrument in writing made after the date of this Contract.
- 24. Payment Terms for Indigenous Sellers It will be mandatory for the Bidders to indicate their bank account n umbers and other relevant e-payment details so that payments could be made through ECS/EFT mechanism instead of payment through cheques, wherever feasible. A copy of the model mandate form prescribed by RBI to be submitted by Bidders for receiving payments through ECS is at Form DPM-11 (Available in MoD website and can be given on request). 25. Advance Payments: No advance payment(s) will be made.
- 26. Risk & Expense clause (a) Should the stores or any installment thereof not be delivered within the time or times specified in the contract documents, or if defective delivery is made in respect of the stores or any installment thereof, the B uyer shall after granting the Seller 45 days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of contract, to declare the contract as cancelled either wholly or to the extent of such default. (b) Should the stores or any installment thereof not perform in accordance with the specifications/ paramet ers provided by the SELLER during the check proof tests to be done in the BUYER's country, the BUYER shall be at liberty, without prejudice to any other remedies for breach of contract, to cancel the contract wholly or to the extent of such default. (c) In case of a material breach that was not remedied within 45 days, the BUYER shall, having given the right of first refusal to the SELLER be at liberty to purchase, manufacture, or procure from any other source as he thinks fit, other stores of the same or similar description to make good:- (i) Such default. (ii) In the event of the contract being wholly determined the balance of the stores remaining to be delivered the reunder. (d) Any excess ofthe purchase price, cost of manufacturer, or value of any stores procured from any other supplier as the case may be, over the contract price appropriate to such default or balance shall be rover ab le from the SELLER. Such recoveries shall not exceed 10% of the value of the contract."
- 27. Inspection Authority: The Inspection will be carried out by Store Office/District Logistics Officer. The m ode of I nspection will be Departmental Inspection/User Inspection/Joint Inspection/Self certification. The m ode of Inspection will be Departmental Inspection and "Firm Fit Function "Certificate from the firm.
- 28. Franking clause– The following Franking clause will form part of the contract placed on successful Bidd er a. Franking Clause in the case of Acceptance of Goods "The fact that the goods have been inspected aft er t he delivery period and passed by the Inspecting Officer will not have the effect of keeping the contract alive. The goods are being passed without prejudice to the rights of the Buyer under the terms and conditions of the contract". b. Franking Clause in the case of Rejection of Goods "The fact that the goods have be en inspected after the 7 / 9 delivery period and rejected by the Inspecting Officer will not bind the Buyer in any manner. The goods are being rejected without prejudice to the rights of the Buyer under the terms and conditions of the contract
- 29. Tolerance Clause– To take care of any change in the requirement during the period starting from issue of RFP till placement of the contract, Buyer reserves the right to 50 % plus/minus increase or decrease the quantity of the r equired goods up to that limit without any change in the terms &conditions and prices qu oted by the Seller. While a warding the contract, the quantity ordered can be increased or decreased by the Buyer within this tolerance limit.
- 30. Ration Item ATCs Demurrage charges In case the rejected items are not lifted by the firm within 48 hrs, the de murrage charges at the rate of 0.5% of total contract value will be charged per day. In case the ite ms are not lifted within a month, the same will be destroyed by the station board of officers and no claim will be admitted. Demurrage charges. In case the rejected items are not lifted by the firm within 48 hrs, the demurrage charges at the rate of 0.5% of total contract value will be charged per day. In case the items are not lifted within a month, the same will be destroyed by the station board of officers and no claim will be admitted.
- 31. Past Project Experience Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria: a. Contract copy along with Invoice(s) with self-certification by the bidder that service/ supplies against the invoices have been executed. b. Execution certificate by client with contract value. c. Any of the document in support of contract execution like Third Party Inspection release note, etc.
- 32. Past Project Experience The Bidder/OEM {themselves or through reseller(s)}, should have executed pr oject for s upply and installation/commissioning of same or similar Category Products during preceding 3 fi nancial years (i.e. cu rrent year and three previous financial years) as on opening of bid, as per following cr iteria: (i) Single order of at lea st 35% of estimated bid value; or (ii) Two orders of at least 20% each of esti

mated bid value; or (iii) Three orders of at least 15% each of estimated bid value. Satisfactory Performance certificate issued by respective Buyer Organizati on for the above Orders should be uploaded with bid. In c ase of bunch bids, the Category related to primary produc t having highest bid value should meet this crite rion.

- 33. Cost of fittings: Bidders should quote for bid including transportation charges, fitment of board including bam boo structure and labor cost. Height of building where board is to be fitted is approx 40 feet from ground.
- 34. Guarantee: Bidders are required to submit guarantee certificate (Minimum 2 Yrs) against weatherproofing/rust ing/fittings/colours etc. any fault found during guarantee period will be met by qualified bidder without any extra charge. Guarantee Certificate on firm's letter head will be mandatory for qualifying in technical evaluation.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer

is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
