- 1. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Bid Pre-Qualification Criteria

- A. The contractor/vendors who have successfully completed similar work in any area will be considered eli gible to participate in tender.
- B. The contractors/vendors are required to submit proof of successfully completed similar type of supply or ders through tendering/local purchase order etc.
- C. Definition of similar work: Painting, phosphating, zinc coating, surface coating of any metallic product, p owder coating, surface treatment, etc.
- D. Supplier must confirm the supply of sufficient manpower's to paint required quantity of boxes per day p er shift as per scope of work.

- E. Firm shall submit compliance of O.F. Bhusawal specification duly signed and stamped on their company's letter head.
- F. Non-compliance of above terms and conditions may result in termination of participation and offer of the Firm will be liable for rejection.
- G. Tender without submission of above supporting documents will be summarily rejected and no further co rrespondence in this regard will be made.

Buyer Added Bid Specific Additional Terms and Condition

- (a) Bidder Financial Standing: The bidder should not be under liquidation, court receivership or similar proc eedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.
- (b) Non Disclosure Declaration Certificate to be uploaded with bid:
- i. I, M/s. _____(Name of the firm) hereby declare that I shall not disclose the contract or any provisi on, specification, plan, design, pattern, sample or information thereof to any third party during and after ex piry of Contract.
- ii. If defying the norms as per the Contract a legal action may be taken against me as per the existing R ules.
- (c) Option Clause: The Purchaser reserves the right to increase or decrease the quantity to be ordered up t o 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to i ncrease the ordered quantity by up to 25% of the contracted quantity during the currency of the contract a t the contracted rates. Bidders are bound to accept the orders accordingly.
- (e) Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in t he Bid document, ATC and Corrigendum if any.
- (f) Safety Norms: The firm shall fulfill all safety norms of OFBH and shall provide all necessary PPEs as per requirement of job. During execution of work if Firm's employee are not following safety norms or found wi thout required PPEs, then penalty of Rs. 1000/- per incident will be imposed. Penalty amount will be deducted by concern User Section at the time of preparation of JCC.
- (g) Inspection: As per Annexure-A by authorized representative of ED/OFBH or His authorized representative e
- (h) Payment will be made on monthly basis within 30 days after submission of Job Completion Certificate (J CC) along with the supporting documents i.e. Tax Invoice and submission of Tax Return/ IFF on GST portal.
- (I) Firm shall submit ATC compliance in their bid for all the mentioned term's & condition as per OFBH BID.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the सामान्य नियम और शर्तै/General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to this Service as provided in the Marketplace.
