1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-

line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

- 2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**** TERMS AND CONDITIONS:

- 1. The service reports should be duly certified by the concerned section/Dept. in charge.
- 2. The service engineer of the firm shall visit regularly to take feedback from concerned section/Dept. in c harge.
- 3. The firm/contractor's representative shall not loiter in BDL premises.
- 4. The technicians have to go through BDL logbook and shall report to concerned section/Dept In charge, t he firm/ contactor has to maintain logbooks and has to record all the maintenance activities and details of spares replaced and should record in service reports.
- 5. No transport will be provided by BDL to your staff .The firm/ contractor shall be responsible for the cond uct of this workmen agents and representatives.
- 6. The contractor is solely responsible for any damage, injury or accident that occurs to any of his personn el during work i.e., will not claim any compensation from BDL.

- 9. During the contract period, if any equipment of the plant found unused permanently by the user, such e quipment shall be deleted from the contract. The list of AC Equipments make: Blue Star at BDL-KBU is at **A nnexure I**.
- 10. Reporting the healthiness of the plant and suggesting improvements if any.
- 11. BDL reserves the right to increase /Decrease the tonnage of A/C plants as per the requirement.
- 12. LD is applicable for compressor only. If the compressor is not brought in working condition within 6 wor king days from the date of intimation, LD of 1.2 times of Tonne rate of that particular compressor will be d educted per day.
- 13. Upon satisfactory performance, the AMC can be extended for one more year with same price, terms an d conditions on mutual consent.

**** PAYMENT TERMS & CONDITIONS:

- 1. Payment will be released on Quarterly basis after consideration of applicable taxes.
- 2. Vendor to submit Service Reports to Indenter/End user immediately after completion of AMC activity & o riginal Invoice to IMM-CPED.
- 3. Vendor Should invariable indicate Item-Wise description, GST rates(in %) SAC Code, your Company GSTI N during submission of delivery challan and invoice.
- 4. Payment will be as per BDL standard payment terms ie..within 30 days of submission of invoice by vend or. Payment will be made against actual service delivered which shall be duly certified by the User.
- 5. Proof of GST remittance may be submitted to IMM-CPED at the time of Invoice submission.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
