### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including add-ons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice

amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

### 3. Buyer Added Bid Specific ATC

- 1- AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of U.P. DOCUMENTARY EVIDENCE TO BE SUBMITTED.
- 2- ISO 9001: The bidder must have ISO 9001 certification.
- 3- The bidder has to submit documents of GST Registration, PAN Card regarding company/LLP/partnership firm as per GEM portal criteria.

- 9- The Minimum average Annual Turnover (MAAT) for the best Three years out of the last Five Financial years should not be less than 100% of the total bid value.
- 10- Prohibition from seeking deposits or security amounts seeking any deposits or security amounts from the deployed resource or any other form of monetary acceptance by the service provider is strictly prohibited. If any such complaint is received, incident will be raised on Gem portal for suitable action as per incident Management policy of Gem in addition buyer department may separately initiate suitable penal action as per their laid down norms.

- 13- Continuity of resources deployed by service provider :- Service provider will ensure continuity of any allocated/deployed resources with the prior consent of the buyer. Deployed resources cannot be replaced by service provider without prior approval of buyer.
- 14- It is binding to the service provider to engage the existing employee on the recommendation of Engineer in charge.
- 15- The Service Provider is required to submit breakup of quoted price (Minimum wages, Admin charges, ESIC, PF etc) on firm's letter head at the time of bidding.
- 16- Manpower Provided by service provider shall not have any employment obligation in any case in present or future.
- 17- Disobedience, misbehaviour with UPPCL staff, lackness in operation of Pump is not acceptable. If any complaint is received on the above subject, the operator will be removed with immediate effect.
- 18- The service provider shall not assign/sub-contract the contract without obtaining the prior written consent of buyer.
