- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in

India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost: or

- 6. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

(i) Availability of office of Service providers: - An office of the Service provider must be located at

Prayagraj District, Uttar Pradesh. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

- (ii) In the event where the distance travel exceeds the monthly uses variant, amount w ill be paid for additional Kms as per schedule. Similarly, the unused Kms in a particular month as against the minimum guaranteed usage variant will be carried forward to the next month and additional Km if any in the next month shall be adjusted against this. However, the payment for the selected usage variant in a month will be paid every mon th. Further, the unused kms in a particular month shall not be carried forward or adjust ed beyond 6 months".
- (iii)The service provider shall pay the toll charges, parking fee or entry taxes payable locally or out station , which shall later be reimbursed by the Buyer on actual basis as paid by the service provid er.
- (iv) Extra per km charges Monthly package cost divided by no. of kms in monthly package multip lied by factor 0.5 in case of normal service and 0.4 in case of 24x7 service.
- (v) Extra hour charges Monthly package cost divided by no. of hours in monthly package multipli ed by factor 0.4. In case of 24x7 service, no charges for extra hours to be paid.
- (vi) Penalty clause for Vehicle Absentee:- There are various ongoing project works und er DY.CSTE/P-I/PRYJ which are being monitored by High level authority and work progre ss is being chased on daily basis. Therefore if vehicle is absent for 01 day then penalty of proportionate payment along with Rs. 500/- will be imposed. If Vehicle is absent for 02 day in a month then penalty of proportionate payment along with Rs.1000/- per day will be imposed. Lastly if vehicle is absent on Three day in a month then penalty of proportionate payment along with Rs.5000/-will be imposed and contract may be terminat ed.
- (vii) Railway administration reserves the right to terminate the contract at any stage before expiry of contract period without assigning any reason whatsoever, and also reserves the right to extend the contract period on the same terms and conditions.
- (viii) Bidder should not mention the offer price in the attachments uploaded in their offer. If they u pload the price document in attachments, then their offer will be summarily rejected.
- (ix) Bidder should submit PF/ESIC certificate of Driver, certified by a Chartered Accountant certificate to be uploaded or certificate issued by the concerned authority who has availed the monthly hiring of vehicle service with LOA/GeM CA clearly mentioned on the certificate.
- (x) The bidder must upload completion certificate mentioning Work Order/LOA/GeM CA No. with the concerned authority' sign and seal, and also upload the same Work Order/LOA/GeM CA along with the completion certificate.
- (xi) The bidder should own 02 (Two) vehicles as per Bid document specification (Model: SUV, year of vehicle: 2025) in its own name and RC should be submitted for 02 vehicles owned by bidder.
- (xii) Bidder to submit an undertaking that Bidder should not have been blacklisted or debarred by any Central/ State Government, Agency of Central/State Govt./PSU/Regulatory Authority of India a t the time of submission of this Bid.
- (xiii) Firm must have an ISO 9001 certificate in the travel agency in registered certificate. The sam

e must be attached to offer mandatorily.

(xiv) Relevant experience certificate as detailed above must be mandatorily attached.

** Similar service contract means

"Bidders shall have experience for execution of service related to Vehicle Hiring in Indian Railway/ Govt. Organization/Semi Govt. Organization / Public Sector Units"

Work experience certificate from private individual shall not be accepted. Certificate from public li sted company/private company/Trusts having annual turnover of Rs.500 crore and above subject t o the same being issued from their Head Office by a person of the company duly enclosing his aut horization by the Management for issuing such credentials.

(xv) The Vehicle is required for supervision/inspection of various ongoing works by officers of this unit. Tentative section of work is Prayagraj to Kanpur, Prayagraj to DDU, and Prayagraj to Manikpu r. The vehicle may have to go to the site of all types of roads, including Kachcha road. The Vehicle shall also be required to go along the Railway embankment for approaching any desired kilometre or site. Any excuse about the condition/existence of the road will not be accepted.

5. Buyer Added Bid Specific SLA

Text Clause(s)

- (i) The Driver/Staff provide with the vehicle must be physical/medically fit, professionally sound an d legally competent in all respect holding valid license prescribed under prevailing motor vehicle A ct and Rules.
- (ii) Contractor shall ensure that enough fuel is available in the vehicle at all time.
- (iii) Driver must have sufficient imprest from contractor to meet with contingencies en-route.
- (iv) Exterior & interior of vehicle has to be dusted daily by the driver, seat cover be of white cloth a nd should be neat & cleaned, floor mats be in good condition and no smell out come during rainy s eason.
- (v) The driver provided by the contractor should fulfill the following conditions:
- a) Should be in possession of valid driving license issued by RTO.
- b) Should not smoke; chew Pan / Pan masala / Tobacco.
- c) Should not indulge in any activity inimical to security of the officers/site supervisors travelling in his car.
- (vi) In case of any road accident or mishap in which the vehicle of contractor is involved and there is loss of life (and injury) or railway, contractor will bear the cost of such losses.
- (vii) Railway administration reserves the right to terminate the contract at any stage before expiry of contract period without assigning any reason whatsoever and also reserves the right to extend the contract period on same terms and conditions.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
