- 1. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

 3. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing

service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The uploading of bid by a bidder implies that bidder has read this notice and the conditions of con tract and has made himself aware of the scope and specification of work to be done and of the conditions and local conditions and other factors having bearing on the execution of the work.
- 2. Accepting officer does not bind himself to accept the lowest or any bid or to give any reason for n ot doing so.
- 3. The rate quoted by bidder shall also includes all taxes/duties i.e. trade tax on works contracts, G ST, custom duty, octroi duty & any other taxes/duties as applicable. This is an express condition of this c ontract no claim of the bidder shall be entertained by MES on this account.
- 4. Firm should be approved /enlisted in MES (attach proof) and Firm should have accreditation/ MoU with any Govt technical institute like IIT/NIT/Any Govt engineering collage/ Govt Technical institute (Attach proof).

Any Government Engineer institute /college or any firm which is collaborative with Government e ngineering institute /collage.

- 5. Firm should have Valid PF/ESI registration number. (Attach registration certificate).
- 6. Firm should have P.HD Geotech on roll in the company at least 6 months old (Attach proof).
- 6. The bidders are required to carefully upload all the necessary documents as mentioned in NIT iss ued by the HQ CWE Chandimandir before bid submission end date. In absence of the uploading of all the requisite documents the bids of the bidder is liable to be rejected without any reference to them.
- 7. Completion of job order shall be issued after successful completion of job and submission of repor t.
- 8. Name of work alongwith Job Number as mentioned in specification should be clearly mentioned I report.
- 9. It will be responsibility of the contractor for layout of the buildings on ground for finalization of loc ations for the bore holes as per the drawings provided by the MES including cleaning of surfaces i.e grass etc if required.
- 10. Submission of binded five copies of ink signed test report duly vetted from Government Technica I institute / Government Engineer collage with detailed description of field investigation, soil classification and general nature of soil strata, water table, interpretation of test results, grain size distribution cures, c ompressive index curves, site plan etc.
- 11. The SBC of the soil is required to given, calculation of bearing capacity will be governed generally as per IS 1892-1972 (Reaffirmed 2002)/NBC2005/SP 36 IS 8009 Part-I 1975, IS-2720 (Part-II)-1 980, IS-6403-1981, IS-1904-1986 & IS-1080-1985 and other relevant IS codes and details calculation dul y showing the various soil parameters/ indices shall be given in the soil report.
- 12. With every site's soil investigation report , a details site plan showing approx location each bore duly numbered as long as bore hole should enclosed. Location of foundation of adjacent structure especi

ally those that might be impacted by the proposed construction.

- 13. Transportation charges including loading and unloading of heavy girder, T&P technician etc comp lete from lab to work site and back shall be deemed to be included in rates quoted by the bidders.
- 14. provide/ suggest the approximate type of foundation and its depth, utilization and dimensions of proposed building to the consultant based on geotechnical investigations, should recommended type of foundation (viz isolated/ combined footing, raft, pile etc).
- 15. Period of completion of the consultancy contract shall be commencing from the placement of Job order.
- 16. Extension of time may be granted for delays caused, which in the opinion of the client, were beyo nd the Consultant's control, provided the Consultant applies for such extension of time in writing within s even days of the occurrence of any event which caused delay.
- 17. If at any time after conclusion of this Agreement, the Client decides to postpone or abandon the Project, he may, by giving seven days' notice in writing to the Consultant, terminate this Agreement, pro vided that if the Project or any part thereof is postponed, the Client, may in lieu of terminating this Agree ment require the Consultant in writing to suspend the carrying out of his services under this Agreement, for the time being.
- 18. Penalty: In case, the Consultant fails to complete the work within the contract period or extended completion period as mentioned in para 4 & 5 above due to reasons attributable to default of Consultant, liquidated damage @1% per week of total lumpsum fees quoted on Schedule of Payment subject to a m aximum of 10% of total quoted lumpsum fees payable under this contract shall be levied on the Consult ant.
- 19. Arbitration: All disputes between the parties to the Consultancy Agreement shall, after written no tice by either party to the Consultancy Agreement to the other of them, be referred to the sole arbitratio n of an Engineer officer or equivalent or having passed final/direct final examination of sub division –II of institution of surveyors (India) recognized by Govt of India to be appointed by Chief Engineer Chandigarh Zone Chandigarh or in his absence the officer officiating as Chief Engineer Chandigarh Zone Chandigarh whose decision shall be final conclusive and binding. If the Arbitrator so appointed resigns his appointme nt o r vacates his office or is unable or unwilling to act due to any reason whatsoever, the authority appointing him may appoint a new Arbitrator to act in his place.
 - (a) The completion certificate will be issued by the Garrison Engineer only after satisfactory completion of Consultancy Services as per the Consultancy and after approval of HQ CWE and CE Office Agreement and after receipt of compliance certificate from the Accepting Officer.
 - **Notes**: (i) Accepting Officer reserves the right to increase or decrease the scope of work dur ing construction stage with mutual consultation with the Consultants and without prejudice to the total technical responsibility of the Consultants.
 - (ii) The broad specifications of the project as indicated here in the tender documents are for guidance and meet the need at the users end.
 - (iii) The Consultant shall visit the site of work after entering into the Consultancy agreement and shall make himself aware of all the site conditions which may affect the structural design of the buildings/structures. The quoted rates shall be deemed to be inclusive of this aspect. DATA/I NFORMATIONTOBE SUPPLIED BY THE CLIENT shall provide following information /details /services to the consultant for completing the work. - 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
