1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
3. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021\\_PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting

bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Scope of supply (Bid price to include all cost components): Supply and delivery of **sodium hydroxide flakes in HDPE Drums** as technical specification annexure attached.
2. Suppliers should upload document duly filled, signed and stamped regarding Self declaration with regards to Local content and also ensure that Local content percentage and location of value addition are clearly mentioned, **strictly as per the format of Annexure XI attached in ATC document, otherwise offer will be rejected.**
3. Suppliers should also upload document duly filled, signed and stamped regarding land border sharing strictly as per Rule 144 (xi) of GFR, **as per the format of Annexure XII attached in ATC document..**
4. Technical data sheet for the supply of Sodium Hydroxide flakes in HDPE Drums attached as Annexure B in technical specification annexure document. Bidder must submit the same duly filled, signed and sealed along with offer, otherwise their offer will be **rejected**.
5. **Delivery Instruction:** Delivery vehicle carrying other than Kalpakkam DAE campus items **will not be permitted** inside by main gate security. **Driver should show original and valid License and accompanying persons should bring at least one valid Government issued proof of identity at the time of delivery.**
6. Sample clause: At least 100 gram of Sodium hydroxide flakes should be submitted to the consignee before each bulk supply after the placement of Purchase Order. . The successful bidder must submit sample to the consignee within 30 days of the purchase order (PO) placement, before initiating each bulk supply. The sample will be approved within 15 days after its submission.
7. Delivery schedule: Delivery shall be in two lots and spread over a period of one year after the placement of purchase order. **Unloading of the material at site will be in the scope of supplier.**

8. Final Acceptance of the product after delivery at site: After analysing the sample taken randomly from the supplied lot at our laboratory for verifying conformity to the specification of the product as per tender. If it is not meeting the specifications, supplier has to replace the material as per the specifications at his own cost within the due date of delivery.
9. Bank Guarantee shall be from SBI or any nationalized bank except Gramin Bank.
10. Post supply inspection is not allowed. Any offer containing the conditions of post supply inspection will be summarily rejected.
- 11. All the other terms & conditions as per the 'buyer added bid specific ATC document' attached shall be adhered to.**
