1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within  $L-1+15\%$  of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. **2. Generic**

Option Clause: Excess Settlement. #### 6. **Purchase Preference (State)**

**Bid reserved for MSE from the State of Bid Inviting Authority:** Procurement under this bid is reserved for purchase from Micro and Small Enterprises from the State of Bid Inviting Authority having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. 1. A reputed Contractor having experience of minimum 03 years running NCC Camp in Higher Educational Institutions of National level is eligible to apply who can cater to the needs of cadets and Officers/Staff.

2. Registration under GST (Certificate to be enclosed)/ If applied copy of document to be enclosed in Bhopal.

3. ESI and EPFO Registration must be uploaded with technical bid.

4. "Bid Security Declaration" as per the annexure.

5. Contractor should have valid FSSAI certificate or have registering for FSSAI for running NCC Camp .

6. Attach minimum experience certificates of approximately 800 persons for running NCC Camp of last three years along with technical bid as proof for providing catering services in NCC Camp.

7. Contractor should have turnover of Rs.10 Lakhs each year in the last three years (Please attach duly attested by C.A. audited balance sheet (FY 2019-20,2020-21,2022-23,2023-24) along with technical bid). 8. Copy of PAN Card (copy to be enclosed.)

9. Whether agreed & able to arrange for Crockery, utensil, Cutlery , equipments like Roti machine, mixer Grinders, Atta Making Machine, Deep Freezer, Arrange as per Requirement of Camp etc. required for running the catering services in NCC camp as per requirement.

10. Whether agreed to abide by all the terms & conditions of this bid.

11. The vendors/Bidders are required to produce a copy of certificate of last THREE years having provided satisfactory services to the clients.

12. AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee (Bhopal only) -DOCUMENTARY EVIDENCE TO BE SUBMITTED.
13. ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.
14. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organization along with Supply/ Purchase Order.
15. Vendor should have Insure that the Services of food as per the menu and provide service day by day on time.
16. Bidder should not be blacklisted from govt. department; undertaking must be uploaded with technical bid document.
17. Buyer reserves the right to cancel the bid at any point of time even after opening of the financial bid.

20. Minimum price should be Rs 220 per person per day.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
