If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. 8. 1. Buyer Added Bid Specific Scope Of Work(SOW)

Scope of work

- 1. It is the primary duty of the successful contractor to ensure that all 10 air-conditioners under the contract are in working condition.
- 2. Type of AMC.
 - (a) Periodicity Preventive Maintenance Once in 3 months.
 - (b) Breakdown Maintenance As and when called for / complaints lodged
- 3. Activities in the quarterly servicing, the contractor should
 - (a) water service the AC unit including water washing of filter,
 - (b) Clean the drain tray and drain pipe,
 - (c) Clean the Evaporator with brush,
 - (d) oiling/greasing of all Fans,
 - (e) checking of current consumption,
 - (f) checking of output performance,
 - (g) testing of Gas pressure if necessary,
 - (h) water washing of Condenser Coil, etc.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Terms and Conditions

- 1. **Introduction**: This document outlines the terms and conditions for the Annual Maintenance Contr act (AMC) along with Operation and Maintenance Servicing of Split Air conditioners (10 Nos.) including spar es at Income Tax Office, Tiruvallur. The AMC aims to ensure the proper functioning and maintenance of the Split Air conditioners as it is essential for office complex.
- 2. **Details of Air Conditioners**: 10 Split Air Conditioners (Make & Modal Voltas, 1.5 Ton, 5 star BEE rated) installed in the office complex.
- 3. **Contract Period**: The AMC will be valid for a period of One year from the date of signing the agreeme nt. The contract may be extended upto 3 months based on satisfactory performance and mutual agreeme nt.

- 4. **Service Level Agreement (SLA)**: The contractor shall adhere to the following service levels:
 - a. Response Time: Within 24 hours of registering a complaint.
 - b. Resolution Time: Maximum of 72 hours for resolving any issue.
 - c. Uptime Guarantee: 99% uptime for the systems during the contract period.
 - d. Penalties may apply for non-compliance with the SLA.
 - e. The contractor shall ensure confidentiality of the data and systems.
 - Any additional work not covered under the AMC shall be executed only after obtaining prior approval f rom ITO, Tiruvallur and at mutually agreed rates.
 - All complaints should be addressed within 6 hrs. In the event of major repairs, complaints should be a ddressed within 48 hrs.

5. Compulsory Terms for compliance:

- a. Bidders are strictly advised not to participate if the Geographical presence is out of **Tiru vallur** (Rental agreement is not considered as a proof of Geographical presence).
- b. Pre-bid meeting: This bid is regarding AMC, to evaluate the operational/Maintenanc e of the installed Split Air Conditioners is considered as mandatory before undertaking the contract. Hence pre-bid meeting is Obligatory. **Only pre-bid meeting participants are considered for te chnical evaluation**.

6. Eligibility of the Contractor:

The contractor must fulfil the following criteria:

- a. Minimum 3 years of experience in maintaining Split Air Conditioners of similar scale and complexity.
- b. Availability of qualified technical personnel for on-site support as required.
- 7. **Liability**: The service provider shall be fully responsible for any damage to the equipment caused due to negligence or improper handling during the maintenance process.
- 8. **Force Majeure**: Any delay or failure in service due to unforeseen circumstances, such as natural dis asters, strikes, or government restrictions, will be dealt with as per the applicable force majeure clause.
- 9. **Payment Terms**: Payment shall be made on a quarterly basis after submission of bills along with serv ice reports. **No advance payment shall be made on any account**
- All bills must be addressed to: Income Tax Officer, Plot No.2, J.N Road, Near Janani Hospital, Tiruvallur 6 02001.
- Tax Deduction at Source (TDS), including TDS on GST, will be deducted as per applicable rules.
- 10. **Rates and Taxes**: The rates quoted shall be inclusive of all taxes. No extra payment on any other a ccount shall be made.
- 11. Earnest Money Deposit (EMD): Not Applicable (due to bid estimated value is below 5 lakhs).
- 12. **Termination of Contract**: ITO, Tiruvallur reserves the right to terminate the contract if the service pr ovider fails to comply with the terms and conditions or if performance is found unsatisfactory. A 30- day no tice period will be given in such cases.
- 13. **Compliance with Regulations:** The service provider must comply with all statutory regulations, including labour laws, safety norms, and any other applicable rules.
- 14. **GeM Terms**: All terms and conditions specified by GeM for tender and contract execution shall be bi nding on the service provider.

- 15. **Dispute Resolution**: In case of any dispute, the matter shall be referred to the Income Tax Officer, Plot No.2, J.N Road, Near Janani Hospital, Tiruvallur 602001 whose decision shall be final and binding on b oth parties.
- 16. **Bid Evaluation**: The L-1 bidder will be selected based on the total value of the contract and not on the rates of individual items.
- 17. Penalty Clause: A penalty of Rs. 100/- per day in each case, will be imposed:
 - a. If delay in repair occurs
 - b. If the contractor doesn't respond through telephone/e-mail within 24 hours.
 - c. If the scheduled visit for repair & maintenance is not adhered.
 - d. If the resolution provided is not satisfactory and fulfils the purpose of repair & maintenance. Conti nued non-performance may lead to the termination of the contract and forfeiture of performance guar antee/security deposit.
- 18. **Performance Security/Guarantee**: The successful bidder shall submit a performance guarantee/se curity equivalent to 5% of the awarded contract value within 15 days of the award of the contract. The se curity shall remain valid for a period of 15 months and can be submitted in the form of an account payee d emand draft/FDR/bank guarantee (including e-bank guarantee) issued by a commercial bank. No interest will be payable on the performance security/guarantee.
- 19. **Maintenance of registers/Log books:** The service provider (L1 Bidder) is required to main tain a Maintenance register containing the details of visit by the authorised person, repairs/Overhauling un dertaken i.e countersigned by the official of Income Tax Office Tiruvallur.
- 20. **Payment Terms**: Quarterly payment will be undertaken to service provider from the date of commencement of contract.

21. Technical Evaluation Criteria:

- a. The service provider must have a local office in Chennai or Tiruvallur only. Documentary eviden ce must be submitted to verify this criterion.
- b. The Bidders should have a valid license/registration with OEM for undertaking electrical work in the state of Tamil Nadu.
 - c. Bidders must have experience of 03 years in same field in any organization public/private.
 - d. Bidders must submit undertaking for non-bankruptcy.
 - e. Bidders must submit undertaking for non-blacklisted.

SAFETY GUIDELINES FOR THE CONTRACTOR:

The Contractor should strictly adhere to the following General safety Guidelines while executing the work:

- 1. Smoking is strictly prohibited at workplace.
- 2. No one is allowed to work at or more than three meters height without wearing safety belt and anchorin g the lanyard of safety belt to firm support preferably at shoulder level. Chinstrap of safety helmet shall b e always on and safety boot is worn.
- 3. Usage of eye protection equipment shall be ensured when workmen are engaged for grinding, chipping, welding and gas-cutting. For other jobs eye protection has to be provided as per the need.
- 4. All safety appliances like Safety shoes, Safety gloves, Safety helmet, Safety belt, Safety goggles etc. sh all be arranged before starting the job.
- 5. Excavated pits for earthing, cable laying shall be barricaded till the backfilling is done. Safe approach to be ensured into every excavation.
- 6. Preferably the work shall be carried out during the daytime. However, adequate illumination at workplac e shall be ensured in case any work is carried out at night.
- 7. Suitable and strong scaffolds should be provided for workmen for all works that cannot safely be done fr om the ground.
- 8. All the dangerous moving parts of the portable / fixed machinery being used shall be adequately guarde d.
- 9. Ladders being used at site shall be adequately secured at bottom and top. Ladders shall not be used as work platforms.
- 10. Debris, scrap and other materials to be cleared from time to time from the workplace and at the time of closing of work every day.
- 11. Other than electricians no one is allowed to carry out electrical connections, repairs on electrical equip ment or other jobs related thereto.
- 12. All electrical connections shall be made using 3 or 5 core cables, having a earth wire.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
