1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. Forms of EMD and PBG

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

5. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

Regional Director, Sports Authority of India Netaji Subhash Regional Center Lucknow A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

6. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. Service & Support

- 1. The bidder needs to submit documents of at least one currently running contract of a similar nature along with a Satisfactory/Good/Very Good Ser vice Certificate in reputed government sports institutions (Central/UT/Stat utory/Autonomous bodies only).
- 2. Past Work Orders minimum of 3 Years along with completion certificates from reputed government Sports Institutions (Central/ UT/Statutory/Auton omous bodies only) in respect of:

- 4. The bidder must have a Goods and Services Tax (GST) certificate of Utta r Pradesh. Bidders must provide the latest GST challan with GSTR 3B.
- 5. Proof of EMD Submission or valid EMD exemption certificate.
- 6. Bank Solvency Certificate amounting to 40% of the estimated value of th is tender document from the scheduled bank. The bank solvency certificate shall be issued in current/ongoing FY.
- 7. Minimum Average Turnover amounting to twice the estimated cost of this stender for the last 3 financial years along with a certificate issued in this regard by a practicing Chartered Accountant.
- 8. Single Labor License of more than 20 nos. of Employees. The bidder mus t possess a valid Labour License Registration Certificate as per the provisi ons of the Contract Labour (Regulation and Abolition) Act, 1970. The certificate must cover a minimum of 20 employees employed by the bidder for the state where the service to be obtained.
- 9. Self-declaration of the bidding agency (signed and stamped) w.r.t. non-bl acklisted from any govt. organization and have not been declared bankru pt.
- 10. Audited financial statement mentioning the net annual profit/loss incurre d for the last 3 years.
- 11. The bidder must possess a valid Provident Fund (PF) Registration Certific ate issued by the appropriate authority in Uttar Pradesh. The bidder must submit the last six months' paid challan related to the Provident Fund con tributions.
- 13. Ensure that the tender document is signed and stamped by the bidding agency on all pages.
- 14. Self-declaration of the bidding agency (signed and stamped) w.r.t. Resources currently employed at SAI NSRC Lucknow to be continued by the successful bidder/service provider under the New Contract.
- 15. The contractor shall pay wages to his worker on or before the 7th of ever y succeeding month, irrespective of delay in payment of Bill by the SAI for whatever reason.
- 16. In case of a death or mishap occurred during discharging the duty the compensation liability will solely rest with the contractor.
- 17. Income tax TDS as per rule shall be deducted from the bill of the contrac tor as per applicable laws.
- 18. The wages shall be paid to workmen without any deduction except those under the payment of wages act and Minimum wages as per Central Gove

rnment Rules Act.

- 19. The SAI reserves its rights to withhold bills, if the contractor fails to prod uce proof for having remitted the ESI and EPF dues as applicable.
- 20. The contractor must get police verification of all his personnel employed at SAI and submit the report to this office along with voter IDs and other valid proof of residence.
- 21. Submission of "Near Relationship Certificate" format enclosed.
- 22. If dispute difference of any kind shall arise between the department and the contractor in connection with or relation to the Contract, the parties s hall make every effort to resolve the same amicably by mutual consultati ons.
- 23. If the parties fail to resolve their dispute or difference by such mutual consultation within twenty-one days of its occurrence, then, either the Department or the contractor may give notice to the other party of its intention to commence arbitration, as hereinafter provided the applicable arbitration procedure will be as per the Arbitration and Conciliation Act, 1 996 of India. In the case of a dispute or difference arising between SAI/ Department and contractor relation to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole arbitration, appointed to be the arbitrator by Sports Authority of India. The award of the arbitrator will be final and binding on the parties to the Contract.
- 24. The Court of Lucknow will have the exclusive jurisdiction to try disputes.
- 25. The contract may discontinued at any time with one month prior information.

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
