1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original

delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

3. Generic

5. Turnover

6. Turnover

OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. 7. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

8. Service & Support

9. Service & Support

10. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

11. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 3 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imberse the cost of such service / rectification to the Buyer.

12. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

13. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

14. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Bids will not be considered for evaluation if the bidder fails to provide detailed technical specifications of all items being offered by them.
- 2. Only those bidders who qualify in technical evaluation will be considered for financial bid evaluation process.
- 3. University authorities reserve all right to accept or reject any/ all bids without assigning any reason. No correspondence and clarification will be entrained in this regard.
- 4. Authorized agents/bidders must submit Manufacturer Authorization Form/ OEM Authorization Certificate from the manufacturer on the company letter head signed by the authorized representative. Such MAF/ Au thorization Letter must clearly specify/ mention the purpose for which it has been issued. The validity period of the MAF/ Authorization Letter must be mentioned in the authority letter.
- 5. Full description & specifications, make/brand and name of the manufacturing firm must be clearly menti oned in the bid, failing which the bid will not be considered. Descriptive literature / catalogues must be att ached with the bid, failing which bid may be disqualified.
- 6. The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and sup plied same or similar Category Products to any Central / State Govt Organization / PSU/ reputed Universitie s during the last three financial years. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the financial year.
- 7. To assist in the analysis, and evaluation, of the bids the competent authority may ask bidders individuall y for clarification of their bids. The request for clarification and the response shall be through GeM Portal o

nly but no change in the price or substance of the bid offered shall be permitted.

- 8. The bidders should furnish a copy of GST Registration Number (the State / U.T. of registration) and the d ate of such registration as well as a copy of their PAN Card. Bids not complying with this condition will be r ejected.
- 9. Force Majeure: Any failure or omission to carryout the provisions of this supply by the supplier shall not give right for any claim by supplier and purchaser to one against the other, if such failure or omission arise s from an act of God which shall include all acts of natural calamities from civil strikes compliance with any statistics and or requisitions of the Government lockout and strikes, riots, embargoes or from any political or other reasons beyond the suppliers control including war (whether declared or not) civil war or state of i ncarceration provided that notice of the occurrence of any event by either party to the other shall be within two weeks from the date of occurrence of such an event which could be attributed to force majeure. Any delay due to Force Majeure will not be attributable to the either of the parties.
- 10. Bidder must enclose unconditional Warranty Certificate of at least one year for the equipment on OEM letterhead. The warranty shall be effective from the date of acceptance of goods. The warranty must cover all parts of the equipment. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down durin g the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubles hooting and Maintenance Service group in INDIA for attending the after sales service.
- 11. In case any false information/ statements/ documents are furnished along with the bid, such bids shall be liable for rejection, and the respective bidder shall be solely responsible for the same.
- 12. The bidder should upload an undertaking on its letterhead stating his/her acceptance and compliance of all the terms and conditions mentioned in the Bid document.
- 13. The bidder/OEM shall furnish an undertaking on its letterhead stating that the firm has never been blac k listed in the past by any Central/ State Govt. Organization/ PSU/ Public Listed Company/ Reputed Univers ity/ Educational Institutions and that there is no vigilance/CBI case pending against the firm/ supplier.
- 14. Legal Jurisdiction:- All disputes and question, if any arising between the University and the bidder out of or in connection with the terms and conditions contained herein or as to the construction of application the reof, or the respective rights and obligations of the parties there under or as to any clause or thing herein c ontained or by reason of the supply or failure or refusal to supply any material or as to any other matter in any way relating to these presents shall be referred to the Sole Arbitrator to be nominated/ appointed by the Hon'ble Vice Chancellor of the MMMUT, Gorakhpur. The decision of the sole arbitrator shall be final and binding upon both parties and subject to adjudication of Gorakhpur Court. Place for arbitration shall be at Gorakhpur (U.P.), India. Venue of such arbitration proceedings shall be MMMUT, Gorakhpur. Arbitration and Conciliation Act 1996 and rules made there under shall be applied to the proceedings under this clause.
- 15. Deduction of TDS will be done as per Govt. Rules.
- 16. Bidders must go through the Buyer Added Bid Specific ATC Document carefully and must ensure that t he technical specifications of the product being offered by them strictly meets the Additional Specifications mentioned in the Buyer Added Bid Specific ATC Document.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
