1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the

date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

- 1. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.
- 2. If the agency is registered under MSME or NSIC, then EMD exemption certificate needs to be enclosed.

3. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

5. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

6. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

7. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

8. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

9. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

1. BCAS clearance certificate is desirable for the agency and the same should be uploaded during bid partic ipation, if available. Those who do not possess a BCAS clearance certificate must upload a self-declaration

stating that the same shall be applied on e-sahaj portal within 15 days of award of contract and shall coor dinate with the concerned authorities for processing temporary Aerodrome Entry Permit (AEP) for the outs ourced manpower till the security clearance is finally approved by BCAS (Annexure 3).

- 2. The Agency must also upload a self-declaration stating that a Program Based Clearance Certificate from BCAS shall be applied within 15 days of award of contract. (Annexure 4)
- 3. The successful Agency will be responsible for processing Aerodrome Entry Permit for the outsourced manpower and must coordinate with the concerned authorities for the same.
- 4. It is desirable for the agency to have an office in the state of consignee (Goa) and the documentary proo f thereof along with the office details need to be uploaded while participating in the bid. In the absence of t he same, the agency must upload a declaration (Annexure 5) to this effect while participating in the bid
- 5. The Buyer organisation reserves the right to accept / reject any BID including lowest BID received through e-bid
- 6. The decision whether to continue contract beyond contract tenure will solely depend on buyer's organis ation with prior approval of competent authority and in case of extension, all the terms and conditions will remain the same. In such cases, the bidder / agency shall be liable to suitably extend the validity of the pe rformance security.
- 7. To be eligible for participating in financial bid, Bidder must upload the required certifications / declaratio ns while submitting the bid document on GeM.

- 8. Bidders are requested to upload toll free number and escalation matrix as per Annexure 2 while particip ating on the BID. It is desirable to communicate "the contact details of the personnel responsible for the o peration in the state of GOA" in the escalation matrix submitted. In the absence of the same, agency must upload a declaration to this effect as per Annexure 6 while participating in the Bid.
- 9. Bidders must upload only the relevant documents in the requested / appropriate format under appropri ate headings. Buyer organisation will not be responsible for technical rejection due to misidentification of r elevant documents because of repeated uploading of same / irrelevant documents.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
