1. 2. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 10. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. On Any day, not more than 50 digitizers would be hired.

2. Payments to wages will not be less than minimum wages fixed by the Labor commissioner. On account of increase in minimum wages, arrear-wages will not be paid by buyer. The Service provider is thus advised to quote the rate in a manner to comply the minimum wages by labor commissioner and also to compensate any price hike during the currency of contract.

3. All financial transaction related to Digitizers shall be in digital mode.

4. All GIS Digitizer should be in uniform provided by the firm. The Bidder has to ensure that all the digitizers comes to office in proper uniform.

5. Firm/bidders should be quoting their service charges/rates taking into consideration above points.

6. This office reserves the right to retain the GIS Digitizers already working in the office under running contract or has worked earlier in this office as they are well trained and experienced as per the project work. Such GIS digitizers are familiar & expert in the work being executed.

7. The bidder is required to mandatorily submit a declaration regarding compliance of all the above points. Submission of declaration is necessary for technical qualification.

8. The bidder shall mandatorily have its office in the state of Chandigarh, Himachal Pradesh, Haryana or Punjab. Document issued by any government department showing the bidder address in the above states has to be submitted as documentary evidence. Rent agreement in this regard shall not be accepted.
