## क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें/**Buyer Added Bid Specific Terms and Conditions**

### 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 3. **Generic**

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

### 4. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

### 5. **Generic**

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

### 6. **Buyer Added Bid Specific ATC**

Quality & Documentation Conditions for Gearbox Internals (Pinion & Gears & Casing):

#### 1. Fitment & Interchangeability Certificate:

OEM (NAW) shall provide a One-to-One Fitment cum Interchangeability Certificate along with the supply, certifying that the supplied spares are fully interchangeable with the existing gearbox components, declaring spares are manufactured as per OEM design, drawings, and process. All dimensions, material of construction (MOC), heat treatment, and critical parameters shall strictly conform to the original supply standards and OEM's proprietary drawings. Reference No./Part Number of the supplied items must match these without deviation. In case of any fitment issues at site, OEM shall replace the defective/non-matching parts free of

of cost without any financial implication to the purchaser.

## 2. Guarantee/Warranty Certificate by OEM (NAW):

The supplied spares shall carry a guarantee/warranty of 12 months from date of installation or 18 months from date of supply, whichever is earlier.

Failure History Clause: If material fails within this time period OEM shall replace the failed part free of cost.

## 3. Material Test Certificate (MTC) from NABL Approved Lab:

- o Chemical composition (MOC): It should match as per Original Supply

- o Mechanical/ Physical properties (tensile, yield, elongation, impact strength)

## 4. Ultrasonic Test (UT) report of forging for internal soundness from NABL Approved Lab.

## 5. NDT/DPT Reports – MPT/DPT after machining to confirm absence of surface cracks.

## 6. Hardness Test Report – surface hardness, core hardness, hardness profile across tooth depth.

## 7. Microstructure Report – confirming metallurgical structure is as per OEM requirement.

## 8. Heat Treatment Certificate – confirming case carburizing/case depth, hardness values, tempering cycle, etc. (As per Industry standard)/.

Note: For Points 5,6,7,8 In case the OEM is unable to provide test certificates from NABL-approved / third-party laboratories, the OEM shall at least furnish test certificates and reports issued from their own in-house quality control laboratory, duly signed and stamped by their authorized QA/QC representative. These reports must clearly indicate traceability to the supplied component (serial number/heat number/part number).

The above reports shall be issued on OEM's official letterhead, duly signed and stamped by the authorized QA/QC head of OEM.

## Packing & Rust-Prevention Confirmation:

### Surface Protection

- All machined/finished surfaces (gear teeth, keyways, etc.) to be coated with suitable rust preventive (VCI oil, grease, or petroleum-based coating).
- Protection must last minimum 12 months under normal storage.

### Moisture Protection

- Wrap each component in VCI paper/polythene or equivalent corrosion-inhibitor.
- Critical parts (pinions, gear wheels) in heat-sealed moisture-proof polybags inside packing cases.
- Desiccants (silica gel) to be provided as required.

### Mechanical Protection

- Pack in strong, seasoned wooden crates/boxes, lined with polythene/laminate sheets.
- Provide adequate cushioning (foam, wooden blocks, thermocol) to avoid shocks/vibrations and prevent metal-to-metal contact. Use wooden separators/rubber spacers for large gear teeth flanks.
- Use wooden separators/rubber spacers for large gear teeth flanks.

## 9. Identification & Handling

- Each package to be clearly marked with Part no/Ref No., description, & handling instructions

## 10. Marking & Identification Certificate –

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.**
