1. 1) ISI Mark :- The product may also carry an ISI Mark as per the BIS standard governing this category.

Buyers may, at their discretion, opt for ISI-marked products by indicating the requirement in the bid, after

taking into account the number of valid licenses issued under the standard. In such cases buyer shall verify valid BIS License as per the governing standard mentioned in the product categories as applicable at the time of evaluation of BID and check the ISI marking on the products at the time of receipt of material before issuing of CRAC.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 2. Generic

After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing– the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

## 3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

## 4. Inspection

#### 9. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1). Buyer has reserved the right to procure the item only from manufacturer or its authorized agent having proven performance. Bidder should have executed 80% of the bidding qty. in a single contract in last thre e years as on Bid opening date in any government organization for consideration of offer. Documentary evidence must be submitted along with offer such as copies of recent Purchase Orders, Receipt notes, GeM Contract &CRAC/CRAN etc. Please note that non submission of such documents shall be taken as the y are not having any such past performance and their offers will be summarily rejected and no representat ion will be entertained.
- 2). Manufacturers or their authorized Distributor/ Dealer/Agent with Bid specific authorization can only quo te. OEMs can authorize and give Bid Specific Authorization to its Agent / dealers to quote on their behalf pr ovided the manufacturer takes full responsibility for the quality of the material including warranty obligation and the inspection of product against order is carried out at the manufacturer's premises. The off 5 / 7er without Bid Specific Authorization Letter will be summarily rejected if bidder is not manufacturer/OEM.
- 3). Bidders are advice to submit the OEM undertaking in their letter head. Details such as email id and cont act number also need to be furnished of authorization letter issuing authority along with head office email to verify the authorization.
- 4). Bidder to give undertaking in their letter head to execute the order as per Buyer specification. Bidder s hould confirm and submit the undertaking otherwise offers will be summarily rejected. undertaking certific ate at ATC: "our offer against gem bid no.\_\_\_\_\_\_ doesn't contain any deviation from the stipulate d 5 / 7 bid conditions and we accept all the terms and conditions of t e bid document without any deviation s." they said undertaking should be provided in a letter head duly sealed and signed by the bidder. Further correspondence in this regard will not be entertained for any reason. Non-submission or incomplete submission of documents may lead to rejection of offer."
- 5). Buying Unit is number. Hence, Bidders are advised to quote prices accordingly.
- 6). The status of firm will be reckoned as on date of Bid opening and not thereafter, unless it is a case of re moval/suspension/banning.
- 7). Time is the essence of contract. As time is the essence of contract, the bidder is to note that the delivery Schedule given in the bid document and quote accordingly. Vague delivery period i.e. 2-28 weeks, 3-8 mon ths etc. or a very high delivery period compared Health department specific delivery period in bid docume nt may be considered commercially unresponsive and offer is liable to be ignored.
- 8). Bidder to give undertaking in their letter head to execute the order within 30 days otherwise offer will be summarily rejected and further correspondence in this regard will not be entertained for any reason.

- 9). Staggered delivery is also applicable as and when required after award of contract.
- 10). Bidder has to attach specific documents and photo and model of the product, otherwise offer rejected.
- 11). Bidder must attach turnover certificate with valid UDIN no.
- 12). Bidder has to attach last 2 years filed ITR copy.
- 13). All bidder has to attach under taking of all Terms & Condition, if not attached offer similarly rejected.
- 14). A copy of the valid drug license must be submitted along with the bid.
- 15). Non-Blacklisted notarized Declaration on 1000/- Stamp paper with bid number mentioned.
