#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 3. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Buyer Added text based ATC clauses:

- (1) Extra per km charges:- As per GEM term and condition.
- (2) Extra hour charges: This case is of 24X7 services, hence no charges for extra hours to be paid.
- (3) In case of non-availability of the assigned driver due to illness, leave etc. it s hall be incumbent upon th e contractor to inform the vehicle using officers about the alternate arrangements either himself or through authorized representatives.
- (4) N0 night allowances for night stay
- (5)Preference will be given if the colour of the proposed vehicle is white.
- (6)The driver of the vehicle should be decent, educated and having knowledge of Hindi/English and living in a clean and tidy manner. Wearing a clean uniform and wearing a name badge. The mobile phone of the driver should always be on . The same driver should be regular and in case of frequent change of driver, the contact will be terminated immediately.
- (7)The interior of the vehicles must be neat and tidy. The seat covers should be of white colors and cleane donce a every week or as and when the conditions warrants. These should be two sets of seat covers.
- (8) All types of expenses like fuel, vehicle repair, driver's monthly payment etc . will be payable by the con tractor. The Railways shall deal with the use of vehicles only.
- (9) The contractor will be responsible for any violation of the applicable laws, rules, regulations, legal notifications, local government/municipal requirements etc. of the Central and State Governments and in case of any kind of fine or accident, the entire due will have to be borne by the contractor.
- (10) The contractor shall be himself responsible for any claim or all claims made under the Workmen's Co mpensation Act or any other act or legislation for the damage caused by the employee employed under him, directly or indirectly, in the performance of the work done under the contract and If there is any loss to the railway, then the railway will compensate the same.
- (11) The vehicle may have to travel any distance within and outside Prayagraj district as per instruction of railway official. And the vehicle can be used for railway work even at night.
- (12) The bidder office must be located at PRAYAGRAJ, Uttar Pradesh and the documentary proof of the sa

me shall be submitted with the bid.

- (13) The bidder shall sign all the document annexed in the bid along with date and bid number of gem and file an undertaking that all the submitted documents are true copy of original. Without this the annexed do cuments shall not be considered as cognizable.
- (14) It is mandatory to attach the copy of Ownership of offered vehicle must be in the name of firm/ Propri etor or Power of attorney for current Bid duly mentioning of Bid number and date. For the complete contra ct period from bidding date.
- (15) It is mandatory to attach latest signed copies of all documents which is ask for this bid such as work e xperience, Financial Turnover, GST Registration certificate, MSME certificate, address proof of registered of fice of the firm, Driver's pa y roll, EPF/Pension deduction, vehicle registration certificate, vehicle insurance etc.
- (16) Toll charges will be paid by service provider.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
