1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. **DOCUMENTARY EVIDENCE TO BE SUBMITTED.**

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

5. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A) Scope of Work :

- i) Providing Skilled Workmen for 24X7 services throughout the contract period at Byculla Works for smooth operation of :
 - a) 22,000 Volts HT Sub-Stations having MOCB in Power House.

- b) Maintaining continuous Electric & Water Supply to Factory, Office Building. Events ,shootings & Weddings and to Guest House Building.
- c) The electrical installations being used by R&C in the Shop
- d) All electrical installations like Fans, AC's Tube Lights, LED Lights, bulbs, flood/street lights, transformers, MCB's etc in Byculla Unit, Peddar Road, Ghatkoper & Mulund Flats.
- ii) You will be required to carry out following work on machineries being used by R&C/R&C's Sub-contractors in the workshop
 - a) Maintenance/preventive maintenance of Capacitors / Capacitor Banks/ Condensers in the R&C/Power House
 - b) Repairing as regards to Switches/Fuses/Cable Faults
 - c) Greasing/Lubrication of moving parts
 - d) Periodical Maintenance of Electrical switches, contactors.
 - e) Maintenance & minor repair work of machinery in the Fabrication Shop such as Welding Rectifiers, SAW Machines, Electrical Grinders, Air Compressors, Electrical DPs/Panels etc. Also to attend shifting of machineries whenever required on the shop floor.
 - f) Periodical Maintenance of Water Pumps - changing of glands, packing and oiling of the pump.
 - g) In case of breakdown, co-ordinating for sending motor for rewinding and Refitting.
- iii) You shall carry out periodical checks and maintain Tube Lights, Light Fittings, Fans, AC Units etc. at our Byculla, Peddar Road Flat, Ghatkopar & Mulund Flats.

iv) You shall record and provide meter readings of various tenants / lessees including monthly rentals and daily rentals viz Events/Shootings/Weddings etc with respect to electrical unit consumption and water unit consumption to R&C for billing purpose.

You will have to undertake all necessary preventive maintenance activities to avoid exorbitantly high billing .You will ensure to provide uninterrupted Electric & Water supply during events at Byculla & Mulund.

v) In case of breakdown of any machinery and if any minor/ major repairs to be done then, the required parts shall be provided by R&C and same are to be replaced / assembled by you.

B) Man power:

You shall provide minimum of 7 persons in each day

- a) 1 electrician + 1 helper in each shift. i.e. total 6 persons in each day**
- b) 1 Plumber (ITI qualification) in each day**

You will arrange to supply one electrician at our Mulund unit during the event days and also as and when necessary.

C) Terms & Conditions

- i. In case of breakdown of any machinery and if any minor major repairs to be done then, the required parts shall be provided by R&C and same are to be replaced/ assembled by you.
- ii. You shall deploy skilled workmen/ supervisor to attend work as described in the Scope of Work.
- iii. You shall have valid Maharashtra Electrical Contractor's License for working in the Company. Your electrician should have minimum qualification of ITI in Electrician trade along with wireman license.
- iv. You shall abide by the rules and regulations of the Factory Act, Central Labour Act and other statutory compliances etc.
- v. You shall pay wages as described in Minimum Wages Act.
- vi. You shall follow safety requirement as per Factory Act. You shall provide Insurance to your Workmen.

vii. You shall comply with statutory levies i.e. PF, ESIC etc for workmen engaged by you.

Viii. You shall maintain the register of labourers, supervisors, engineers engaged by you in our works with personal data. You shall provide photo identity badges to them. The daily attendance will be recorded. If any damage to any machineries occur due to negligence of your labourers then such cost shall be recovered from your bill(s).

ix. You shall maintain the register and records in Form No. I, II, IV, V and X etc as per applicable Rules. Also you will display notice containing minimum rate of wages as per the Contract Labour (Regulation and Abolition Act 1970). You shall comply all the statutory compliances and as per applicable Labour Act/ code in force.

x. The bidders shall have their registered office in Mumbai/ Mumbai Suburban/ Navi Mumbai/ Thane only. Others will be rejected & no correspondence in this regard will be entertained.

D) Payment Terms:

You shall submit monthly bill in duplicate on or before 3rd of every month. The company shall release the payment by 7th of every month. The monthly bill shall include applicable Taxes/GST.

Further the bill shall accompany the following:

I Proof of having paid PF/ESIC (statutory dues) and attendance sheet.

E) Tenure:

The tenure of the contract will be for a period of 1 year from the date of work order.

F) Termination :

If at any stage, your workman causes damages and or act detrimental to working of the company, then the contract will be terminated.

After the contract is made, the contract may be cancelled by either party by giving one month written notice, without giving any reason(s) thereof.

Note: R&C reserves the right to accept or reject any offer without giving any reason whatsoever it may be. R&C, at its discretion, may cancel the tender at any stage before awarding the contract to successful bidder.

Bidders must to attend the pre bid meeting and then to visit the site for inspection in order to assess the quantum of work to enable them to quote, competitively.

In case if any bidder could not attend the pre-bid meeting on the date specified due to pre-occupancy, they may send a letter to our company before the pre-bid meeting date (i.e. R&C) requesting to allow them to do site inspection on the next working day after the pre-bid meeting date.

The Buyer may relax the norms of any clause.

Amount given in the bid estimated value is indicative purpose only. Bidders have to make their own assessment after inspecting the site.

Those who agree to these Buyer added specific ATC terms only need to participate in the Bid.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
