- 1. - 4. - 5. # ADDITIONAL TERMS AND CONDITIONS FOR INVITATION TO BID AND INSTRUCTIONS TO BIDD ER (ITIT)

- **1. Nature of requirements:** To fix the rate for the hiring of Deluxe Bus for E ducational Tour during the year 2025-26. The Accepted BID (A.T.) holder sho uld have to provide the services for Educational Tour.
- 2. The Sardarkrushinagar Dantiwada Agricultural University (SDAU) sh all in first instance prefer to deal with Transport Agencies. However, on meri t basis the competitive offers of reputed traders will also be considered. The Bidder should preferably have track record of supply of Deluxe Bus for at le

ast last three years to any Govt. Department / Educational / Agricultural University in the country (Attach relevant list or certificate pertains to client satisfaction in this regard).

- **3. VALIDITY OF BID:** The rate quoted shall initially be valid up to 31st March, 2026. However, it may be extended by the university.
- **4. PAYMENT:** The payment will be made only by the ordering office. No advance payment shall be made. The payment shall be made by respective office after satisfactory completion of Exposure Tour.
- **5. INSPECTION:** SDAU Indenter/consignee or authorized representative may do inspection of Deluxe bus, if needed.
- **6. TERMINATION OF CONTRACT:** SDAU reserve rights to cancel bid or termi nate this contract without prejudice to the bidder, if bidder party/their firm f ail to supply deluxe bus in accordance with the prescribed terms and conditi ons. The decision of the SDAU shall be final as regards the acceptability of d eluxe bus supplied by the Bidder and the SDAU shall not be required to give any time for the rejection of the contract.

# 7. OTHER TERMS AND CONDITIONS:

- 7.1. Transporter / Bidder have to quote the lump sum amount (Rs.) of deluxe bus, which include the expenditure on diesel, oil, RTO tax, parking charge, toll tax, road tax, passenger tax, and any other permit (including GST (CGST & SGST), and any other service tax etc.
- 7.2. Transporter / Bidder have to supply the one Deluxe bus (Non-AC) of 56 seats capacity with sitting arrangement of 3 x 2 having push back facility. The Transporter/ bidder have to quote the total lump sum amount (Rs.) of Non-AC Deluxe bus.
- 7.3. The Deluxe bus should be in good condition viz; all windows have glasses, window glass can be e asily open and close, seat cover, video coach facilities.
- 7.4. Transporter / Bidder have to provide the Deluxe bus of their own ownership having model of 2021 to 2025 only.
- 7.5. If required, traveling during night time should also be carried out.
- 7.6. The bus shall have to be taken to the places as per schedule of tour programme as per attached scope of work file, bidder is required to carefully go through documents and that mentioned route is purely tentatively for rough approximation of idea for tour schedule and destination for tour ope rator and not restricted to including journey kilometer mentioned in schedule documents.
- 7.7. Deluxe bus should be taken to the nearest point of visit of institutes/places as per the directions of tour leader/s (Not to drop the students/staff at far away from places of visit).
- 7.8. Total duration of exposure tour is 13 days (from 12-11-2025 to 24-11-2025) which includes visit o f different institutes of Western India (As per Scope of work documents of Tour programmes). Ther efore, Transporter / Bidder have to take necessary R.T.O. permissions before the beginning of the educational tour.
- 7.9. Education tour will start from university head quarter Sardarkrushinagar (U.G. Hostel Block, Colle ge of Basic Science and Humanities, S. D. Agricultural University, Sardarkrushinagar) at 07.00 AM on 12-11-2025. So, Transporter / Bidder have to send their one Deluxe bus at least two hours bef ore the schedule departure time at Sardarkrushinagar.
- 7.10. Transporter / Bidder have to provide insurance cover to all the students and faculty/staff member s with unlimited insurance and copy of same shall be uploaded online and submit offline to this office.
- 7.11. Transporter / Bidder has to repair or replace the Deluxe bus if it will take more than six hours time for repairing of bus when the bus is on route and shall have to continue the tour as per schedule wi thout fail.

- 7.12. No Money in cash/online mode will be given by Tour Leader/University for diesel, oil, RTO tax, parking charge, toll tax, road tax, passenger tax, and any other permit (including GST (CGST & SGST), and any other service tax and maintenance, breakdown or towing, trans port and other hidden charges during Educational Tour to tour operator or driver by institute. F or these contingent expenditure Transporter / Bidder has to make necessary arrangement of finance in advance by their own.
- 7.13. During Educational tour, if Deluxe bus if by chance meet accident/breakdown of, the entire respon sibility will lie on the Transporter / Bidder.
- 7.14. If required to change the Deluxe bus, then Transporter / Bidder may replace the bus having same facilities with prior approval of the university at the cost of Transporter / Bidder.
- 7.15. In the event of an order being placed against this BID and if Bidder fails to supply the Deluxe bus in accordance with the terms and conditions of Acceptance of BID or fail to replace any Deluxe bus within such times as may be stipulated, the SDAU shall be entitled to take services of other Travel company, without notice to the Bidder, from any other source and at such price as the university s hall in the sole discretion think fit. If such price exceeds the rate set out in the schedule to accepta nce of bid, the Bidder shall be responsible to pay the difference of the price at which such services have been finalized by the SDAU.
- 7.16. Transporter / Bidder have to provide the copy of permit of travel at-least one week before start of educational tour.
- 7.17. To change the route of educational tour is solely at the discretion of Tour Leader/ Tour In charge.
- 7.18. Transporter / Bidder have to provide the photocopy of documents of registration of Deluxe bus, R. C. books, base license of the drivers and insurance of buses. The same shall have to be uploaded o nline as well as send set of all these documents physically also.
- 7.19. The last date for physical submission of sealed cover of bid documents (Security deposit, BID fee and copy of all these relevant documents in separate covers placed within a cover) is 09-09-2024. However, if the last date of submission of BID documents is declared as a holiday by the Governme nt, the last date of submission of BIDs will be considered as extended to the next working day. No BID will be accepted after prescribed closing time for submission of the same. The delay will not be condoned for any reason whatsoever including postal / transit delay.
- 7.20. Kilometres will be counted from Sardarkrushinagar (starting point) to Sardarkrushinagar (ending point) during educational tour.
- 7.21. No advance payment will be made by university to meet various contingent expenditure to be ma de by Transporter / Bidder for educational tour. The total payment shall be made only after satisfactory completion of Educational Tour.
- 7.22. Head office/ Registered office of the firm/ Bidder/ transporter should be located in Gujarat state.
- 7.23. The drivers should have valid and working license of driving heavy vehicles during mentioned jour ney periods.
- 7.24. No traveling allowance and dearness allowance will be paid to the bus driver, conductor /cleaner, mechanic and other personnels of the Transporter / Bidder by University.
- 7.25. The expense of lodging, boarding, breakfast, tea and food for the bus driver, conductor /cleaner, mechanic and other personnel/s of Transporter / Bidder shall be borne by Transporter / Bidder.
- 7.26. Transporter / Bidder have to provide disciplined, honest, obedient and teetotaler staff for educatio nal tour.
- 7.27. The staff of (the bus driver, conductor/cleaner, mechanic and other personnels) Transporter / Bidd er should have to strictly follow the instructions given by Tour Leader / In charge Officer from time to time
- 7.28. The bus should be cleaned regularly before start of journey daily.
- 7.29. Transporter / Bidder have to deploy the drivers having well skill to drive heavy vehicles in hilly tra ct also.
- 7.30. The Bidder should read this document and the instructions / terms and conditions therein very car

efully. Any Bidder who does not confirm with the instructions / terms and conditions herein is liable to be rejected without any reference.

- 7.31. In case of any dispute between Transporter / Bidder and University, the decision of university shall be final and binding to the Transporter / Bidder.
