Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### **TERMS AND OTHER CONDITIONS :**

1. Firms which are having status “**SUSPENDED**” within last 1 year of generation of Bid in GeM portal, the firms will not be considered for technical evaluation. The Seller has to submit self-certification regarding the same along with technical bid. Format is enclosed along with Bid.
2. The Seller has to comply and execute the work as per scope of work & Annexure A attached along with the Bid.
3. **PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer along with all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.
4. The offers of Sellers who are on watch listed status will not be accepted at the time of technical evaluation. Also all watch listed sellers will be excluded while RUN L1 selection by the system.
5. The Minimum Wages will be amended as per change in minimum wages as notified by Ministry of Labour time to time and no separate TPC will be held for the same.
6. Firm has to execute the work as per GeM Service level agreement for Service Category Manpower Outsourcing Service –Minimum Wages and its amendments issued from time to time

#### **Experience & Turnover Criteria :**
