1. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity

supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

##### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

##### 2. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

##### 3. OEM

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

##### 4. Purchase Preference (Centre)

Indian suppliers of this item are not allowed to participate and/ or compete in procurement by some foreign governments. Bidders / products from such countries are not eligible / not allowed to participate in this bid in terms of clause 1 (d) of Public Procurement (Preference to Make in India) Order, 2017

## 5. **Warranty**

Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

## 6. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

- (a) **Bid Security Declaration**. Bid security declaration is required from the bidder on their letter head in the form of Earnest Money Deposit (EMD). Bid security is not required to be submitted by those bidders who are registered with central purchase organisation i.e DGS&D, NSCI, DGQA, MSME or similar procurement organisation of Military of Defence for the same items/range of products, goods or service which the bid have been issued.
- (b) **Performance Bank Guarantee**. The vendor will deposit a performance Bank Guarantee by way of Bank Guarantee through a public sector bank or a private sector bank authorized to conduct government business (ICIC Bank Ltd, Axis Bank Ltd or HDFC Bank Ltd) for a sum equal to 5% (three percent) of the contract values 5 lakh and above) within 30 days of placement of this contract. Performance bank Guarantee will be valid upto 60 day beyond the date of warranty.
- (c) **Warranty**. If within a period of 36 months from the date of inspection/ successful installation of stores against this order, any defect due to design, workmanship or materials is found to or stores are defective for any other cause whatsoever, the same shall be replaced by you at site free of charge within a period of 15 days of the receipt of an intimation from the purchaser unless the purchaser, in his sole discretion agrees to the removal of the defect by you or somebody else at your cost and acceptance thereafter if the stores are then found according to the Army requirement.
- (d) **OEM/ Authorisation Certificate**. is required to be submitted by bidder along with their technical bid. Their party authorisation certificate will not be acceptable.
- (e) **MSME Certificate**. - Upload MSME certificate with same and similar product.
- (f) The supplier/ firm must be Original Equipment Manufacturer (OEM) a authorised Distributors/ Reseller of the OEM. The bidders are essentially required to submit a valid authorisation from the OEM on all applicable items as mentioned in technical specification, failing which the bid shall be rejected.
- (g) Bidder establishment should be 3 years above (Submit Proof) and must submitted Net worth attested by the CA.
- (h) **Undertaking** - Undertaking on 100 rupees non judicial stamp paper should be submitted that the entire document provided are true by the bidder and must be uploaded on GeM portal and stamp paper date after bid publish date.
- (j) All the documents should be self-attested on bidder company letter head with company stamp signature.
- (k) Demonstration of Technical Parameters will be sought from successful L1 Bidder before commencement of supply to ensure requisite quality.
- (l) Acceptance of Technical Specification Certificate should be submitted.
- (m) Seller should not be bankrupt, blacklisted of any government agency in last three years. Ce

rtificate should be provided in stamp paper of Rs 100/- and date of stamp paper should be after bid publish date.

(n) **Inspection of Stores.** The advance sample/ consignment will be inspected by a board of officer detailed on behalf of accepting authority. The advance sample consignment will be checked against specification in GeM contract and sample held with consignee.

(o) **Rejected Stores.** In case of entire consignment/ part consignment is rejected by the accepting authority, it is the responsibility of the supplier to collect the rejected quantity from consignee location within 7 days of intimation of rejection. The cost involved will be borne by the supplier.

(p) **Supply of Rejected Quantity.** In case of entire consignment/ part consignment is rejected by the accepting authority, it is the responsibility of the supplier to supply the rejected quantity within the delivery period. No extension of delivery period will be granted on ground of rejection.

(q) **Exemption from Experience and Turnover Criteria MSEs.** Exemption to be given only on producing relevant documentary evidence certifying if the firm is the production/ manufacturing unit offered product and not the re-seller/trader.

(r) **Registration with DPIIT.** Registration of the participating firm with DPIIT is mandatory as per addendum to Rule 144 (XI) of GFR. Bidder (incl Indian) having commercial arrange with any entity from countries which share land borders with India also need to register with DPIIR. Any such documents wrt country origin/ country of manufacture/ Bill of Material/ Supply visibility/ OEM details may be asked during technical evaluation stage at any stage of procurement to verify the claims.

(s) **Proc from Countries sharing border with India.** Bidder from a country sharing land border with India is reqd to submit certificate of registration as per GOI/ Min of Fin (Department of Expenditure) OM No F7/10/2021-PPD dt 23 Feb 2023 regarding restriction under Rule 144 (xi) of GFR 2017.

(t) **Country of Origin.** Country of origin of the eqpts & components will be explicitly specified. The invoice trails to ascertain the country of origin may be verified during the technical evaluation.

(u) Compliance cert of each technical parameter of bids shall be submitted by the bidder in the bid documents with firm official stamp and signed.

(v) Firm should submit catalogues for the products.

(w) No Debarment of Vendors certificate.

(x) Bidder/ OEM should be submitted certification: CE, EEC, FCC, MET, Microsoft Hardware certification report of the offered tablet and certification: BIS, Dun & amp: Bradstreet, CE, ISO 50001:2011, 9001: 2015, 14001 : 2015 of the offered UPS.

(y) The offered tablet should be tops 5 IDC and the certificate regarding the same required to be submitted.

(z) All bidders are requested to compulsorily attend the pre bid meeting. Bidder who will not attend the meeting considered as rejected in TEC & marked as disqualified.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
