1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

1. General Instructions:

- Bidders must carefully read and understand all details before submitting the bid.
- Incomplete or incorrect bids are liable to be rejected.
- The entire responsibility regarding correctness of information, quality, and compli ance with specifications lies solely with the bidder.

2. Eligibility:

- The bidder must be a registered supplier/firm capable of supplying all listed items as per the tender document.
- Experience in similar supply works (furniture, books, electrical items, etc.) will be preferred.

3. Submission Requirements:

- The bidder must sign and stamp all pages of the tender document as a token of ac ceptance of all terms and conditions.
- The bidder must attach a quoted item list (without prices) along with the tender d ocument at the time of submission.
- After financial opening, the bidder must submit a detailed break-up price of each i tem as per requirement.

4. Items to be Supplied:

- All items must be new, unused, and of standard quality.
- Books must include general-purpose reading materials and reference books covering competitive exams, undergraduate, and graduate level subjects.

5. Quality Standards:

- All products should meet standard quality and specification requirements.
- Defective, damaged, or substandard items will be replaced by the bidder at their o wn cost.

6. Local Support Preference:

- Preference will be given to local bidders for installation and after-sales service, es pecially for inverter and battery setup.
- In case of any fault or malfunction, the bidder must ensure timely service and repair without delay.

7. Delivery and Installation:

- Delivery and installation of all items must be completed within the specified time mentioned in the work order.
- All transportation, handling, and installation costs shall be borne by the bidder.

8. Payment Terms:

- Payment will be made only after successful delivery, installation, and inspection of all items by the Panchayat authority.
- No advance payment will be made.
- Proper invoice/bill along with necessary documents must be submitted.

9. Warranty / Guarantee:

- A minimum one-year warranty must be provided for all applicable items.
- Any defect or issue within the warranty period must be resolved by the bidder at n o additional cost.

10. Taxes and Duties:

- All applicable taxes and duties must be included in the quoted price.
- No additional tax claim will be accepted after submission.

11. Penalty for Delay:

- Delay in supply or installation beyond the stipulated time may attract a penalty as per P anchayat rules.
- Non-performance may lead to cancellation of order and blacklisting of the bidder.

12. Bid Validity:

• The bid shall remain valid for 90 days from the date of submission.

13. Inspection:

- The Panchayat or authorized committee reserves the right to inspect and verify the supp lied materials before acceptance.
- The committee's decision regarding quality and quantity shall be final and binding.

14. Right to Accept / Reject:

• The Panchayat reserves the right to accept or reject any or all bids without assigning an y reason.

15. Legal Jurisdiction:

• In case of any dispute, the jurisdiction will lie under theconcerned district court.

3. Scope of Supply

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
