- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

ATC

01. **Completion** The Works shall be completed to the entire satisfaction of t he G.E and in accordance with the Service providers forecast of time and progress where operative.

On receipt of notice from the Service provider that the work has been completed, the G.E. shall within seven days certify to the Contractor the date(s) on which the items or group of items of Works are completed.

- 02. Cancellation of Contract in part or in full for Service providers **D** efault. If the Service provider-
 - (a) Makes default in commencing the Works within a reasonable time f rom the date of the handing over the Site, and continues in that state afte r a reasonable notice from G.E.

or

(b) in the opinion of the G.E. at any time, whether before or after the d ate or extended date for completion, makes default in proceeding with the Works, with due diligence and continues in that state after a reasonable notice from G.E.

Or

(c) fails to comply with any of the terms and conditions of the Contract or after reasonable notice in writing with orders properly issued thereund er.

Or

(d) fails to complete the Works, Work order and items of Works, with in dividual dates for completion and clear the Site on or before the date of c ompletion.

The Accepting Officer may, without prejudice to any other right or remed y which shall have accrued or shall accrue thereafter to Government, cancel the Contract as a whole or only such Work Orders or items of Work in default from the Service provider.

03. **Advances on Account** The Service provider may at intervals of not le ss than 30 days for contracts of value less than Rs. 50 lakh and 15 days in case of contract more than 50 lakhs submit claims, provide the payment due is not less than Rs. 50,000/-.

The Service provider shall be entitled to be paid in respect of such claims at the following percentages of the value of work executed on the Site to the sat isfaction of the [Garrison Engineer]

(a) For Works not exceeding Rs. 5 lakhs.

90 percent of the value of work executed.

(b) For Works exceeding Rs.5 laKH BUT NOT EXCEEDING Rs. 10 lakhs.

90 percent of the value of work executed for the first 5 lakh and 92^1 /₂ percent of the value of work executed for the balance.

(c) For Works exceeding Rs. 10 lakhs.

90 percent of the value of work executed for the first 5 lakh, $92^{1}/_{2}$ p ercent of the value of work executed for the next 5 lakh and 95 percent of the value of work executed for the balance.

04. Final Bill

The Final Bills shall be submitted by Service provider in duplicate within t hree months of certified completion of the Works to the satisfaction of the Engin eer-in-Charge.

It shall be accompanied by all abstract, vouchers, etc., supporting it and s hall be prepared in the manner prescribed by the G.E.

No further claims shall be made by the Contractor after submission of the Final Bill and these shall be deemed to have been waived and extinguished.

The Contractor shall be entitled to be paid the Final sum less the value of payments already made on account, subject to the certification of the final bill by the G.E.

- 05. **Arbitration.** All disputes, between the parties to the Contract (other than those for which the decision of the C.W.E. or any other person is by the Contract expressed to be final and binding) shall, after written notice by either party to the Contract to the other of them, be referred to the sole arbitration of a ¹[Ser ving officer having degree in Engineering or equivalent or having passed final/direct final Examination of sub-Division II of Institution of Surveyor (India) recognised by the Govt. of India] to be appointed by the HQ CEUZ.
- 06. **Defect liability period**: The defect liability period for the work will be 30 (thirty) days.
- 07. **Refund of performance security: -**The performance security deposit will be refunded to bidder afte r expiry of defect liability period provided always that the bidder shall have been paid the final bill and have rendered No-Demand Certificate (I.A.F.W. 451).

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
