1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. The Pre-qualification/eligibility criteria

- i. Firms which are established & registered for tendered item at Or dnance Factory Dehu Road, Pune (OFDR) or at sister factories (est ablished with the MIL group of factories/erstwhile OFB) as decided by concerned VSL TPC are only eligible to participate in the instant LTE, hence, other than established & registered vendor for the tendered items will not be allowed to participate. - In following cases bidders will be technically disqualified out rightly without asking any clarification from the bidder and no correspond ence will be entertained during evaluation of bids & against repres entation/challenge after technical evaluation published on Gem Por tal.
 - Bids received with matching/common IP address with either Bidder(s)/Seller(s) or Buyer, shall be out rightly rejected without asking any clarification from the bidder(s) & shall not be considered for further evaluation. Collusion of IP address will be considered as suspected cartel formation, hence necessary action as deemed f it may be taken against such bidders.
 - As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of th 2. e Manual for Procurement of Goods 2017, issued by Ministry of F inance, Department of Expenditure, During evaluation and comp arison of bids, the purchaser may, at his discretion, ask the bidd er for clarifications on the bid. All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
