Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 5. Terms of payment : Payment should be made within 30 Days after successfully receipt of store as 100% serviceable condition.
6. Items should be delivered within 24 hours.
7. Items should be Replacement policy min 30 days.
