4. **Certificates**

i) Additional kilometres /hours beyond package: Package of 2000 Kms and 300 Hours per month, beyond which fixed Rs. 10/Km and Rs. 100/Hour shall be paid (Including GST). These charges will not be taken into evaluation of bid.

ii) Deductions shall be made in terms of penalty clause against the bills pertaining to the days of unsatisfactory service and non-fulfillment of contract condition as reported by the user.

a) Late reporting - 100/-Per day.

b) Non-reporting - 1000/- Per day

c) Refusal of duties - 500/-Per instance

d) Change of drivers without prior intimation/ Providing improper drivers - 500/- per instance

In case of non-reporting the per day rent for Vehicle on pro-rata basis will be deducted apart from the above penalty.

iii) No change of vehicle(s) or driver (s) will be allowed without prior permission of RITES.

iv) In case of break down of the vehicle, the contractor shall provide the replacement (of same category ve

hicle) with in a reasonable time falling which the touring executive will be entitled to hire any vehicle and complete the journey and amount thus incurred shall be recovered from the bills of the contractor.

v) All kinds of repair/maintenance costs, charges of fuels, oil, lubricants, mobile phone charges, fee toward s licenses/registration, challans, salary/overtime of the driver, upto date comprehensive insurance/ pollution certificate etc are responsibility of the contractor and all be bone by the contractor throughout the duration of the contract.

vi) The contractor shall ensure compliance of all applicable laws such as Motor Vehicle Act and adhered to legal and labour provisions provided by the Government of India/state which shall include income tax, accidents, employee state insurance, provident fund, minimum wages act, contract labour and abolition act etc. The contractor shall provide all the necessary details as required by RITES for passing of bill/invoice.

vii) The contractor shall ensure that only on pay roll drivers should be deployed for duty. The drivers should be in proper uniform with name badges and photo Identity card.

viii) Along with every monthly bill vendor is supposed to get certification from the user that the vehicle is assigned is not more than 2 yrs old model and having valid PUC.

ix) The price quoted shall cover all aspects of service delivery, it shall be inclusive of all consumables required to provide the service, Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regard. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST%. Supplier shall ensure that the invoice is raised in the name of consignee with GSTIN of consignee only.

x) Log Books shall be maintained to record the operation time shall be signed by RITES authorized representative. The bill shall be made on the basis of record in the Log Book. The mileage & time reckoning shall be recorded / counted from residence of RITES Officer in Charge.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
