- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.
- 5. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

- 01- OEM and authorized dealer are allowed to participate in the Bid, the proof of which Must be uploaded with bid mandatory like OEM authorization letter.
- 02- EMD AMOUNT: Bid Earnest Money- Rs 14174 i.e. 1% of estimated bid val ue Rs. 1417392 in favor of DIS TRICT HEALTH SOCIETY SAMBHAL in form of Fixed Deposit Receipt. Hard copy of EMD will be submitted be fore bid o pening date at CMO OFFICE SAMBHAL. Without EMD, The bidder will not be qualified in technical Bid. EMD in form of Fixed Deposit Receipt of succe ssful bidder will also be considered as a Performance Security. Department reserves the right to forfeit the Performance Security in the event of the firm violating any of the terms and conditions of the contract or for not providing satisfactory and/or quality and timely services.
- 03- SAMPLE: Bidder is required to submit the sample of MCP Card mentioned in BID along with the report of competent agency/lab mentioning the GS M and quality of samples paper in the favor of chief medical officer Samb hal in a sealed envelope containing the name and address of the firm and the details of Items at CMO OFFICE SAMBHAL before bid opening date. Without Sample, The bidder will not be qualified in technical Bid.
- 04- FINANCIAL STATEMENT: At the time of submission of bid, Bidder has to s ubmit Audited Balance Sheet with Audit Report with UDIN No. and ITR of the Bidder's Firm in last three Financial Years.
- 05- Packing instructions: Successful bidder must have to supply the material in such a manner that is prescribed by the department.

- 06- SCOPE OF SUPPLY: Bid Price to include all cost including transportation a nd installation charges (if any) in Department, Material will require for DIS TRICT HEALTH SOCIETY, SAMBHAL only. No additional charges will be give n.
- 07- No separate charges for carrying out corrections, copy editing, compiling formatting, designing and bin ding will be admissible.
- 08- Experience: Bidder firm should have 3 years' experience in last three Fin ancial Years s (i.e. 2022-23, 2023-24 & 2024-25). It is mandatory for the b idder firm should have earlier experience of successfully completing printing and binding work in medical health and family welfare department /PS U's/other govt Department, the proof of which Must be uploaded with bid mandatory like copy of work order, Contract and Invoice.
- 09- Copy of PAN Card & Aadhar Card of Authorised Person & Valid GST Regis tration Certificate Must be uploaded with bid mandatory.
- 10- Bidder must have a financial capacity of 50% value of Estimated Bid Value, Solvency certificate issued by District Magistrate or Nationalized Bank, must be uploaded with bid mandatory.
- 11- Affidavit Duly Notarized on Rs.10 Stamp Paper: · That the firm is not blac klisted in any terms by any Govt. - 12- ASSURANCE FOR QUALITY CONTROL: Bidder should be ISO Certified for the Items to be supplied and must upload ISO 9001:2015 Certificate.
- 13- All items shall be supplied by the successful bidder, strictly in accordanc e with the specification attachments and conditions stated. If any discrepa ncy find out in Supplied items, Department are not bound to accept such i tems.
- 14- If Bidder submits any fake documents, the department will take legal action against Bidder/Firm; the jurisdiction shall be Sambhal only.
- 15- The Department reserves the right to increase or decrease the quantity to be ordered. Bidders are bound to accept the orders accordingly.
- 16- The successful bidder must have to supply all the material within 15 day s of the Bid awarded.
- 17- It is mandatory for Bidder to upload all the papers with stamped and self -attested.
- 18- Bidder's offer is liable to be rejected if they don't upload any of the certi ficates / documents sought in t he Bid document, ATC and Corrigendum if any.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
