- 1. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
- 3. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 4. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
  - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

### 3. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

## 4. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

### 5. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

### 6. Inspection

Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER): Before

dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the Buyer. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. While bidding, the sellers should take into account 7 days for inspection from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be on the part of the buyer and shall be regularised without Liquidated Damages.

When there is requirement of submission the advance sample, the seller shall inform the buyer promptly through emails about the date of submission of sample to the buyer nominated Inspection agency.

#### 7. Forms of EMD and PBG

. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

## 8. Buyer Added Bid Specific ATC

- 1. Bidder must be Authorized by the OEM for offer products (for Pole and Light Both), authorization certificate with bid number and bid opening date mandatorily mentioned on it, need to be enclosed with bid documents.
- 2. Bidder need to upload OEM's make in India certificate for offer products. Minimum local content use in offer product must be  $\geq$  50 %.
- 3. Compulsory to upload OEM's Factory License along with bid documents.
- 4. OEM company must have in house NABL testing facility for testing of led lights. Certifica te and scope of the same, must be enclosed with bid documents.
- 5. Bidder need to submit declaration on notarized 10 Rs. stamp paper that his firm has not been blac klisted, debarred and Forbidden in any Government, Semi government, PSU, Govt. Undertaking depar tment and Urban Local bodies for any reason in last three years. If the declaration given by bidder is f ound incomplete, wrong, manipulated and fake, then same bid will be cancelled and appropriate acti on will be taken against the bidder.
- 6. OEM must have ISO 9001 certification, Same need to upload with bid documents.
- 7. OEM of the offer products need to submit declaration on notarized 10 Rs. stamp paper that OEM compa

ny has not been blacklisted, debarred and Forbidden in any government, Semi government, PSU depart ments, Govt. Undertaking Departments and Urban Local bodies for any reason in last three years. If the declaration given by OEM is found incomplete, wrong, manipulated or fake, then same offered bid will be cancelled and appropriate action will be taken against the OEM.

- 8. Driver of the offer products must be potted and technical parameter of the driver should be as per direction of UPPWD. Technical data sheet of the same need to be enclosed to confirm the same .
- 9. BIS number of the driver must be Engraved/Screen Printed/Embossed on the driver. Photo sam ple of the driver need to be enclosed with technical bid documents.
- 10. For hassle-free replacement of defective lights, OEM must need to submit 2% of the drivers in advance in Buyer store. Once the defective drivers have been replaced with advance drivers by department, the defective drivers will be given back to OEM/Bidder, who must then submit the same number of fre sh drivers again as advance drivers. The process will remain the same during the warranty period. OEM needs to upload declaration on its letter head that company will follow the above said process till the time of warranty period of offer product.
- 11. If company forbid to follow the process for submission of 2% advance drivers (Reference to point nu mber 10 of bid conditions), any time within warranty period, then appropriate action will be taken agains t the OEM.
- 12. Five-year replacement warranty on OEM letter head with bid number and date mandatorily mention ed on it, individually for LED Street light and Try Color Pole, need to be enclosed with bid documents.
- 13. Price list of offer product need to be enclosed with bid documents.
- 14. In case of partnership firm, Bidder need to attached partnership deed along with bid doc uments.
- 15. Bidder needs to provide declaration on notarized 100 Rs. Stamp paper that no near and blood rel ative is working in NAGAR PALIKA PARISHAD KHEKRA, BAGHPAT, UTTAR PRADESH.
- 16. Address Proof & ID. Proof of Individual/Partners/Directors along with Pan card and GST certificate of the firm need to be enclosed with bid documents.
- 17. Technical parameter/specification of the Led light and its driver, offered by bidder in bid, should be same as per directed in UP PWD schedule. To confirm the same, technical data sheet of the offered product needs to be submitted along with bid documents.
- 18. LED Street lights must have IP66 protection. IP66 test report from NABL certified lab, need to be enclosed with bid documents.

- 19. An authorized employee of the OEM Company, needs to visit the store of Buyer in order to veri fy that the product being supplied by their authorized reseller is genuine material of the company. He/she is also required to submit warranty and genuinity certificate to the office, of buyer, with pro duct model number and batch code number mentioned on it.
- 20. The procuring entity reserves the right to reject this tender / any bid / all bids at any time, wi thout giving any reason to bidders.
- 21. OEM must submit documentary evidence/ Job sheet for successfully replacement of defective light or its parts, within last three years, from any government departments.
- 22. Documentary evidence/ Job sheet for successfully replacement of defective lights or its parts in gov ernment departments must be acknowledged (signed and stamped) by respective departments.
- 23. BIS certificate for LED Street lights along with its driver, needs to be enclosed with bid do cuments.
- 24. LM79 report of the offered product (Only for Street Lights), from any NABL lab, need to be enclo sed by bidder along with technical bid documents.
- 25. OEM need to provide an Email id/Toll free number to concern department for register any def ective issue in offered product.
- 26. OEM of the offer product need to submit declaration on notarized 10 Rs. Stamp paper that OEM will address complaints about defective LED lighting (sent by the department via email or toll-free number) within Seven working days of the department's complaint date.
- 27. Department can ask any NABL Certified lab to check the parameter of the offer product, if any dis crepancy found in testing, then bid will be cancelled and necessary action will be taken against the O EM.
- 28. Bidder needs to attach drawing of the Indian Flag Color Pole along with bid documents.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
